4 **Resolution authorizing the Airport Commission to accept and expend federal funds in a**
5 **total amount of \$15,000,000 from the Transportation Security Administration (TSA**
6 **Agreement Number HSTS04-04-A-DEP125) for the Installation of Explosive Detection**
7 **Baggage Inspection systems (EDS) at San Francisco International Airport.**

8 WHEREAS, In response to the September 11, 2001 terrorist attacks, Congress passed
9 the Federal Aviation and Transportation Security Act, which requires all checked baggage to
10 be screened for explosives; and,

11 WHEREAS, The Transportation Security Administration (TSA) contracted with The
12 Boeing Company to implement interim and partial permanent explosive detection baggage
13 inspection systems (EDS) at the San Francisco International Airport's Domestic Terminals;
14 and,

15 WHEREAS, The TSA has not provided sufficient direct funding to accomplish the
16 implementation of a complete permanent in-line EDS; and,

17 WHEREAS, Completion of permanent in-line EDS is a necessity for state of the art
18 100% checked baggage inspection, and to mitigate the negative impact on airline operations
19 and passenger convenience; and,

20 WHEREAS, The estimated total cost to complete the permanent in-line EDS at the
21 Domestic Terminals is \$22,700,000; and,

22 WHEREAS, The Airport has executed an Other Transaction Agreement (OTA) (TSA
23 Agreement Number HSTS04-04-A-DEP125) with the TSA to build and fund the terminal
24 modifications and construction necessary to implement permanent in-line EDS; and,

1 WHEREAS, a binding obligation or commitment has been made by the TSA to
2 reimburse the Airport \$15,000,000 of the costs; and,

3 WHEREAS, All indirect services provided by the City to the Airport and the
4 Commission are covered in the Annual Service Payment pursuant to the Lease and Use
5 Agreement between the City of San Francisco and the major airlines using San Francisco
6 International Airport, with request for additional reimbursement for indirect services in this
7 grant being prohibited, the requirements of Section 10.170 of the San Francisco
8 Administrative Code are deemed satisfied; now, therefore, be it

9 RESOLVED, That the Airport Commission, which has jurisdiction over the San
10 Francisco International Airport, is hereby authorized to accept and expend federal funds in the
11 amount of \$15,000,000 to complete the permanent in-line explosive detection baggage
12 inspection systems in the Domestic Terminals; and, be it


13 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of






