3 **Motion suspending Rule 5.42 of the Rules of Order of the Board of Supervisors to allow**  
4 **the Board of Supervisors to consider, without waiting 30 days after its introduction,**  
5 **Ordinance amending Chapter 8 of the Administrative Code by amending Section 8.8**  
6 **regarding obsolete law books and other published materials.**

8 WHEREAS, Rule 5.42 of the Rules of Order of the Board of Supervisors requires that  
9 when a measure is introduced that would create or revise major City policy, the measure shall  
10 not be considered until at least 30 days after the day of the measure's introduction; and,

11 WHEREAS, Rule 4.38 of the Rules of Order of the Board allows Rule 5.42 to be  
12 suspended by the affirmative vote of eight members of the Board, unless there be less than  
13 eight members present, in which case the unanimous consent of the members present, but  
14 not less than six members, shall be required; and

15 WHEREAS, The members of the Board of Supervisors wish to suspend the operation  
16 of Rule 5.42 with regard to the consideration of File No. 001964, Ordinance amending  
17 Chapter 8 of the Administrative Code by amending Section 8.8 regarding the obsolete law  
18 books and other published materials; and

19 WHEREAS, If this motion is adopted, File No. 001964 will be heard at the regularly  
20 scheduled Audit and Government Efficiency Committee meeting of December 5, 2000, which  
21 is 29 days after the legislation was introduced, only one day short of the 30 days prescribed  
22 by Rule 5.42; now, therefore, be it

23 **MOVED, That the Board of Supervisors of the City and County of San Francisco, as**  
24 **allowed by Rule 4.38 of its Rules of Order, hereby suspends the operation of Rule 5.42 of its**

1 Rules of Order from operating with regard to the Board's consideration of this amendment of  
2 Chapter 8 of the Administrative Code.


