Motion suspending Rule 5.42 of the Rules of Order of the Board of Supervisors to allow the Board of Supervisors to consider, without waiting 30 days after its introduction, Ordinance amending Chapter 8 of the Administrative Code by amending Section 8.8 regarding obsolete law books and other published materials.

WHEREAS, Rule 5.42 of the Rules of Order of the Board of Supervisors requires that when a measure is introduced that would create or revise major City policy, the measure shall not be considered until at least 30 days after the day of the measure's introduction; and,

WHEREAS, Rule 4.38 of the Rules of Order of the Board allows Rule 5.42 to be suspended by the affirmative vote of eight members of the Board, unless there be less than eight members present, in which case the unanimous consent of the members present, but not less than six members, shall be required; and

WHEREAS, The members of the Board of Supervisors wish to suspend the operation of Rule 5.42 with regard to the consideration of File No. 001964, Ordinance amending Chapter 8 of the Administrative Code by amending Section 8.8 regarding the obsolete law books and other published materials; and

WHEREAS, If this motion is adopted, File No. 001964 will be heard at the regularly scheduled Audit and Government Efficiency Committee meeting of December 5, 2000, which is 29 days after the legislation was introduced, only one day short of the 30 days prescribed by Rule 5.42; now, therefore, be it
