6 WHEREAS, The Resolution establishing the Calle 24 ("Veinticuatro") Latino Cultural  
7 District seeks to memorialize a place whose richness of culture, history and entrepreneurship  
8 is unrivaled in San Francisco; and

9 WHEREAS, The Resolution presented to the Board of Supervisors for approval  
10 erroneously includes in its boundaries La Raza Park (also known as Potrero del Sol Park) and  
11 Precita Park; and

12 WHEREAS, The Board of Supervisors approved Resolution No. 168-14 that contained  
13 an erroneous description of the boundaries of the Calle 24 ("Veinticuatro") Latino Cultural  
14 District; and

15 WHEREAS, The Resolution should at page 1, line 17 should read: "The boundary of  
16 the Calle 24("Veinticuatro") Latino Cultural District shall be the the area bound by Mission  
17 Street to the West, Potrero Street to the East, 22<sup>nd</sup> Street to the North and Cesar Chavez  
18 Street to the South, including the 24<sup>th</sup> Street commercial corridor from Bartlett Street to Potrero  
19 Avenue. Additionally, the Calle 24("Veinticuatro") Latino Cultural District shall include the  
20 Mission Cultural Center because of the community and cultural significance associated with  
21 this place;" now, therefore, be it

22 RESOLVED, That the Board of Supervisors hereby approves a correction to the  
23 Resolution No. 168-14 striking "La Raza Park (also known as Potrero del Sol Park) and  
24 Precita Park from the Resolution; and, be it


