

1 [Commending Dr. Stan Hill]  
2 COMMENDING DR. STAN HILL FOR ELEVEN YEARS OF SERVICE AS THE ARTISTIC  
3 DIRECTOR OF THE SAN FRANCISCO GAY MEN'S CHORUS AND DECLARING JULY 21,  
4 2000 "DR. STAN HILL DAY" IN THE CITY AND COUNTY OF SAN FRANCISCO.

6 WHEREAS, Dr. Stan Hill began as Artistic Director of the San Francisco Gay Men's  
7 Chorus on August 1, 1989; and,

8 WHEREAS, During Dr. Hill's tenure with the Gay Men's Chorus, the Chorus has seen  
9 dramatic organizational growth, including the tripling of its membership, the doubling of its  
10 annual audience, and the release of six dramatically successful recordings; and,

11 WHEREAS, Dr. Hill's accomplishments with the Gay Men's Chorus include the  
12 premieres of important commissions such as the Susa orchestration of Brahms' *Vier Ernste*  
13 *Gesänge*, the Wayne Love orchestrations of the Bernstein Medley, the Seeley/Littell  
14 commission of *NakedMan*, and the Richard Francis Rogers' commission *Q*; and,

15 WHEREAS, Dr. Hill was also responsible for bringing important new music to San  
16 Francisco such as Roger Bourland's *Hidden Legacies* and the wonderful arrangements of  
17 David Maddux, including *ExtrABBAGanza!*, and *Swellegant Elegance*, performed in the War  
18 Memorial Opera House with guest star Harvey Fierstein; and,

19 WHEREAS, Dr. Hill produced all nine of the San Francisco Gay Men's Chorus'  
20 recordings as well as the *Exile!* recording due out in July 2000; and,

21 WHEREAS, Dr. Hill is moving to Minneapolis to become the Artistic Director of the  
22 Twin Cities Gay Men's Chorus; and,

23 WHEREAS, Dr. Hill's last performance with the San Francisco Gay Men's Chorus will  
24 be July 21, 2000; now, therefore, be it
