1 WAIVING THE PERMIT FEE THAT THE FIRE DEPARTMENT WOULD
2 OTHERWISE CHARGE THE UCSF CAROL FRANC BUCK BREAST CENTER IN
3 CONNECTION WITH THE OCTOBER 7, 2000 TASTE FOR THE CURE.

5 WHEREAS, October is Breast Cancer Awareness Month; and

6 WHEREAS, Breast cancer is the most common form of cancer in American women and
7 the leading cause of cancer related death in women; and
8

9 WHEREAS, One woman in eight will develop breast cancer in her lifetime; and

10 WHEREAS, The University of California at San Francisco Comprehensive Cancer
11 Center is hosting a variety of events in October to raise funds and awareness to combat breast
12 cancer; and

14 WHEREAS, On October 7, 2000 the UCSF Carol Franc Buck Breast Cancer Center will
15 host the Second Annual Taste for the Cure, an event that will feature San Francisco chefs and
16 restaurants and focus on healthy food and the role that healthy eating can play in lowering the
17 risk of breast cancer; and

18 WHEREAS, The Fire Department has mandated that the organizers of the Taste for the
19 Cure secure a permit for the event at a cost of approximately \$180; and

21 WHEREAS, Proceeds from the Taste for the Cure will be used to purchase a van with a
22 mobile mammogram, making mammograms available to women who might be otherwise unable
23 to obtain a regular mammogram; and

WHEREAS, Mammography is a crucial tool in the early detection of breast cancer and
can literally save lives; now, therefore be it

RESOLVED, That the San Francisco Board of Supervisors of the City and County of
San Francisco waives the permit fee that the Fire Department would otherwise charge the UCSF
Carol Franc Buck Breast Center in connection with the Taste for the Cure on October 7, 2000.
