WHEREAS, Proceeds from the Taste for the Cure will be used to purchase a van with a mobile mammogram, making mammograms available to women who might be otherwise unable to obtain a regular mammogram; and

RESOLVED, That the San Francisco Board of Supervisors of the City and County of San Francisco waives the permit fee that the Fire Department would otherwise charge the UCSF Carol Franc Buck Breast Center in connection with the Taste for the Cure on October 7, 2000.
