3 **Resolution determining that the transfer of a Type 20 off-sale beer and wine license**  
4 **from 599 Clement Street to 1957 Union Street (District 2), to Melissa Gisler for Gusto**  
5 **Partners, LLC, dba Spuntino di Ottimista, will serve the public convenience and**  
6 **necessity of the people of the City and County of San Francisco, in accordance with**  
7 **Section 23958.4 of the California Business and Professions Code, with conditions.**

10 WHEREAS, Melissa Gisler is seeking the transfer of a Type 20 off-sale beer and  
11 wine license from 599 Clement Street to 1957 Union Street (District 2), for Gusto  
12 Partners, LLC, dba Spuntino di Ottimista; and,

13 WHEREAS, The Planning Department has verified that the area is properly  
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business  
18 and Professions Code, the Board of Supervisors of the City and County of San  
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 20  
20 off-sale beer and wine license to Melissa Gisler for Gusto Partners, LLC, dba Spuntino  
21 di Ottimista, located at 1957 Union Street, will serve the public convenience and  
22 necessity of the people of the City and County of San Francisco.

23 Conditions: (1) Sales of alcoholic beverages shall be permitted only between the  
24 hours of 8:00 a.m. and 8:00 p.m. each day of the week. (2) Not more than 15% of the  
25 square footage of the premises will be used for the display of alcoholic beverages. (3)

1 No noise shall be audible beyond the area under the control of the licensee(s). (4)  
2 There shall be no coin operated games or video machines maintained upon the  
3 premises at any time. (5) No person under the age of 21 shall sell or deliver alcoholic  
4 beverages. (6) No wine shall be sold with an alcoholic content of greater than 15% by  
5 volume except for "Dinner Wines" which have been aged two years or more and  
6 maintained in corked bottles. (7) No malt beverage shall be sold with an alcoholic  
7 content greater than 5.7% by volume. (8) No beer or malt beverage products shall be  
8 sold, regardless of container size, in quantities of less than six per sale, and wine-  
9 coolers and beer coolers must be sold in manufacturer pre-packaged multi-unit  
10 quantities. (9) Graffiti shall be removed from the premises and all parking lots under the  
11 control of the licensee within 72 hours of application. If the graffiti occurs on a Friday or  
12 weekend day, or on a holiday, the licensee shall remove the graffiti within 72 hours  
13 following the beginning of the next weekday. (10) The petitioner(s) shall be responsible  
14 for maintaining free of litter the area adjacent to the premises over which they have  
15 control. (11) The petitioner shall not permit their patrons or the general public to loiter or  
16 congregate on the area adjacent to the licensed premises.


