3 **Resolution approving modification no. 4 to contract no. 300 with Neoplan USA**  
4 **Corporation in the amount of \$36,036,898.00, to exercise an option for 24 articulated**  
5 **clean diesel coaches and 71 standard clean diesel coaches, including purchase of**  
6 **associated spare parts and incorporation of design modifications, for a total contract**  
7 **amount not to exceed \$128,229,473.00.**

9 WHEREAS, After a competitive negotiated procurement in accordance with the  
10 provisions of Administrative Code Section 6.05 and the Negotiated Procurement Procedures  
11 adopted pursuant to Section 6.05, on February 5, 1999, the Board of Supervisors approved  
12 Resolution No. 60-99, which authorized the Public Transportation Commission ("MUNI") to  
13 enter into Contract No. 300 ("Agreement") with Neoplan USA Corporation ("Neoplan"), for the  
14 purchase of 100 new articulated, high floor clean diesel coaches and 135 new standard, high  
15 floor clean diesel coaches, for a total contract amount not to exceed \$92,192,575; and

16 WHEREAS, The Agreement contains an option for up to 24 articulated, high floor clean  
17 diesel coaches and up to 151 standard, high floor clean diesel coaches, which option must be  
18 exercised by June 29, 2001; and,

19 WHEREAS, MUNI wishes to exercise the option for 24 articulated, high floor clean  
20 diesel coaches and 71 standard, high floor clean diesel coaches, and purchase associated  
21 spare parts and special tools, as authorized by Municipal Transportation Agency Board  
22 Resolution No. 00-128, approved on December 19, 2000; and

23 WHEREAS, MUNI wishes to incorporate design changes that have been ordered since  
24 the Agreement was executed; and




