

1 [Animal Control and Welfare Commission]  
2 AMENDING SECTION 41.1 OF PART II, CHAPTER V, ARTICLE I OF THE SAN  
3 FRANCISCO MUNICIPAL CODE (HEALTH CODE), ESTABLISHING A COMMISSION OF  
4 ANIMAL CONTROL AND WELFARE, BY AMENDING THE SECTION TO DESIGNATE THAT  
5 ONLY MEMBERS APPOINTED BY THE BOARD OF SUPERVISORS SHALL CONSTITUTE  
6 VOTING MEMBERS.

7 Note: Additions are underlined; deletions are in ((double parentheses)).

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Part II, Chapter V, Article I of the San Francisco Municipal Code (Health  
11 Code) is hereby amended by amending Section 41.1, to read as follows:

12 SEC. 41.1. COMMISSION OF ANIMAL CONTROL AND WELFARE; MEMBERSHIP;  
13 APPOINTMENT; TERM. There is hereby established a Commission to be known as the  
14 Commission of Animal Control and Welfare of the City and County of San Francisco  
15 (hereafter called "Commission"), consisting of 11 members.

16 The Commission of Animal Control and Welfare shall consist of the Director of the  
17 Animal Care and Control Department or his or her designated representative, seven members  
18 to be appointed by the Board of Supervisors and one City Department representative member  
19 appointed by each of the following: the Director of the Department of Public Health or his or  
20 her designated representative, the Chief of Police or his or her designated representative, and  
21 the General Manager of the Recreation and Park Department or his or her designated  
22 representative. The members appointed by the Board of Supervisors shall be six members  
23 representing the general public having interest and experience in animal matters and one  
24 licensed veterinarian practicing in San Francisco. Each member of the Commission of Animal

1 Control and Welfare of the City and County of San Francisco shall be a resident of the City  
2 and County of San Francisco, except for the licensed veterinarian, who must practice in San  
3 Francisco, but who need not be a resident of San Francisco.

4 Voting members of the Commission shall consist only of the seven members appointed  
5 by the Board of Supervisors. The Director of the Animal Care and Control Department, the  
6 Director of the Department of Public Health, the Chief of Police, and the General Manager of  
7 the Recreation and Park Department, or their designated representatives, shall report to the  
8 Commission regarding their respective Department's activities, and participate in general  
9 discussions before the Commission as non-voting members.


10 Three of the members who are first appointed by the Board of Supervisors shall be  
11 designated to serve for terms of one year and three for two years from the date of their  
12 appointment. Thereafter, members shall be appointed as aforesaid for a term of two years,  
13 except that all of the vacancies occurring during a term shall be filled for the unexpired term. A  
14 member shall hold office until his or her successor has been appointed and has qualified. The  
15 Commission shall elect a chairman from among its appointed members.

16 Any member who misses three regularly scheduled meetings of the Commission during  
17 each two-year term without the express approval of the Commission given at a regularly  
18 scheduled meeting will be deemed to have resigned from the Commission.

19 The term of office as chairman of the Commission shall be for the calendar year or for  
20 the portion thereof remaining after each such chairman is elected. No member of the  
21 Commission shall receive compensation for serving thereon.


