1 [Master Lease Amendment - United States Navy - Treasure Island Marina]

3 **Resolution approving Amendment No. 19 to the Treasure Island Marina Master Lease**  
4 **between the Treasure Island Development Authority and the U.S. Navy to extend the**  
5 **term for one year, for the period of December 1, 2015, through November 30, 2016.**

7 WHEREAS, The Treasure Island Development Authority ("Authority") and the United  
8 States of America, acting by and through the Department of the Navy (the "Navy"), entered  
9 into a master lease dated September 4, 1998, for the Authority to use and sublease certain  
10 land and structures on former Naval Station Treasure Island (as amended from time to time,  
11 the "Marina Master Lease") at no rent; and

12 WHEREAS, The Marina Master Lease enables the Authority to sublease portions of  
13 the master leased area for interim uses and generate revenues to support the interim  
14 operation of Treasure Island and the future redevelopment of the former Naval Station  
15 Treasure Island; and

16 WHEREAS, The term of the Marina Master Lease expires on November 30, 2015; and

17 WHEREAS, The Authority wishes to extend the term of such lease for a period of one  
18 (1) year beginning on December 1, 2015, and ending on November 30, 2016, unless sooner  
19 terminated in accordance with the terms and conditions of the Master Lease; and

20 WHEREAS, The Navy concurs with such amendment and the amendment has been  
21 approved by the Authority Board of Directors at its July 8, 2015, meeting; and

22 WHEREAS, The Board of Supervisors Resolution establishing the Authority, AB 699  
23 and TIDA's Bylaws require that the Authority obtain Board of Supervisors approval of any  
24 agreements having a term in excess of ten (10) years or anticipated revenues of \$1,000,000  
25 or more; and

1           WHEREAS, Because the cumulative term of the Marina Master Lease exceeds ten (10)  
2 years, the Authority is requesting that the Board of Supervisors approve the Nineteenth  
3 Amendment to extend the term of such lease for a period of one (1) year beginning on  
4 December 1, 2015, and ending on November 30, 2016, unless sooner terminated in accordance  
5 with the terms and conditions of the Master Lease; now, therefore, be it

6           RESOLVED, That the Board of Supervisors hereby approves and authorizes the  
7 Treasure Island Director or his designee to execute and enter into the Nineteenth Amendment  
8 to the Marina Master Lease in substantially the form filed with the Clerk of the Board of  
9 Supervisors in File No. 150782, and any additions, amendments or other modifications to  
10 such Nineteenth Amendment (including, without limitation, its exhibits) that the Treasure  
11 Island Director or his designee determines, in consultation with the City Attorney, are in the  
12 best interests of the Authority and do not otherwise materially increase the obligations or  
13 liabilities of the Authority, and are necessary or advisable to effectuate the purpose and intent  
14 of this resolution; and, be it

15           FURTHER RESOLVED, That within thirty (30) days of the Nineteenth Amendment  
16 being fully executed by all parties, the Authority shall provide the final Nineteenth Amendment  
17 to the Clerk of the Board for inclusion into the official file.

**Resolution approving Amendment No. 19 to the Treasure Island Marina Master Lease between the Treasure Island Development Authority and the United States Navy to extend the term for one year, for the period of December 1, 2015, through November 30, 2016.**

**SUMMARY OF PROPOSED ACTION:**

This item seeks approval and authorization to amend the Master Lease between the Treasure Island Development Authority (the "Authority") and the U.S. Navy (the "Navy") for the Marina on former Naval Station Treasure Island to extend the Term of the Lease to November 30, 2016.

**BACKGROUND:**

On September 4, 1998, the Authority entered into Lease Number N6247498RP00Q01 with the United States Navy (as amended from time to time, the "Marina Master Lease"). The lease premises include certain land and buildings, including the Treasure Island Marina, the marina boat slips and the Treasure Island Yacht Club. The Authority does not pay any base rent under the Marina Master Lease, and the Authority uses the subleasing and permit revenues to support the interim operation of Treasure Island. The Master Lease is renewed yearly.

The term of the Marina Master Lease will expire November 30, 2015. The proposed Nineteenth Amendment extends the term through November 30, 2016 on the same terms and conditions as the existing Marina Master Lease.

The Authority's Board of Directors approved the Nineteenth Amendment to the Marina Master Lease at its July 8, 2015 meeting. Pursuant to the Board of Supervisors Resolution establishing the Authority, AB 699 and TIDA's Bylaws, Board of Supervisors approval is required of any contract or agreement entered into by the Authority with a term longer than ten years. Because the term of the Marina Master Lease exceeds ten years, the Director of Island Operations requests approval of the Nineteenth Amendment from the Board of Supervisors to extend the term to November 30, 2016 on the same terms and conditions as the existing Master Lease.

**RECOMMENDATION:**

Approve the Nineteenth Amendment to the Marina Master Lease between the Treasure Island Development Authority and the United States Navy to extend the term to November 30, 2016.

**NINETEENTH AMENDMENT  
TO LEASE AGREEMENT N6247498RP00Q01  
BETWEEN  
THE UNITED STATES OF AMERICA  
AND  
TREASURE ISLAND DEVELOPMENT AUTHORITY**

THIS LEASE AMENDMENT made this \_\_\_\_ day of \_\_\_\_\_ 2015, by and between the UNITED STATES OF AMERICA, acting by and through the Department of the Navy, hereinafter called the "Government", and the TREASURE ISLAND DEVELOPMENT AUTHORITY, hereinafter called the "Lessee";

WHEREAS, the parties hereto, as of 4 September 1998, entered into Lease Agreement N6247498RP00Q01 under the terms of which the Lessee uses certain real property for space located at the former Naval Station, Treasure Island; and

WHEREAS, the parties agree to amend the terms of the Lease Agreement.

NOW THEREFORE, in consideration of the terms, covenants and conditions hereinafter set forth; the following paragraphs to Lease N6247498RP00Q01 are hereby amended to reflect the following changes;

1. Paragraph 2 **TERM**, delete in its entirety and the following paragraph is inserted therefore:

"The term of this Lease shall be for a period of one (1) year beginning on 1 December 2015 and ending on 30 November 2016, unless sooner terminated in accordance with the provisions of Paragraph 14, Termination."

2. Paragraph 19 **SUBMISSION OF NOTICES**, delete Government's address and insert the following:

All other terms and conditions of the Lease Agreement shall remain in full force and effect.
