2 Endowment to fund the Palace of Fine Arts Rotunda Restoration Project]

4 **Resolution authorizing the San Francisco Recreation and Park Department to accept**  
5 **and expend a grant in the amount of \$1,451,250 for the restoration of the Palace of**  
6 **Fine Arts Rotunda , under Proposition 40 California Clean Water, Clean Air, Safe**  
7 **Neighborhood Parks, and Coastal Protection Act of 2002 administered by the California**  
8 **State Library, California Cultural and Historical Endowment.**

10 WHEREAS, The California Cultural and Historical Endowment has received an  
11 appropriation from Propositions 40 California Clean Water, Clean Air, Safe Neighborhood  
12 Parks, and Coastal Protection Act of 2002, which provides funds to the State of California for  
13 grants to eligible Applicants; and

14 WHEREAS, The California Cultural and Historical Endowment may distribute funds  
15 from Proposition 40 to Projects that provide a thread of California's cultural and historical  
16 resources; and,

17 WHEREAS, The Palace of Fine Arts Rotunda Restoration Project meets the objectives  
18 of the CCHE program; and,

19 WHEREAS, The California Cultural and Historical Endowment has been delegated the  
20 responsibility for the administration of and the grant Project shown above within the State,  
21 setting up necessary procedures; and,

22 WHEREAS, The Applicant will enter into a contract with the State of California for the  
23 Project; and,

24 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; and,

25 WHEREAS, The grant does not require an ASO amendment;

3 acceptance and expenditure of local assistance in the amount of \$1,415,250 for Palace of  
4 Fine Arts Restoration Project from the California Cultural and Historical Endowment Program  
5 under the Proposition 40 California Clean Water, Clean Air, Safe Neighborhood Parks, and  
6 Coastal Protection Act of 2002; and, be it


7 FURTHER RESOLVED, That the City and County of San Francisco waives inclusion of

9 FURTHER RESOLVED, That the City and County of San Francisco certifies that  
10 Grantee has or will have sufficient funds to operate and maintain the project; and, be it

11 FURTHER RESOLVED, That the City and County of San Francisco certifies that  
12 Grantee has reviewed, understands and agrees to the General Provisions contained in the  
13 Contract shown in the Procedural Guide; and, be it

14 FURTHER RESOLVED, That the City and County of San Francisco appoints the  
15 Project Manager of the Department of Public Works as agent to conduct all negotiations,  
16 execute and submit all documents including, but not limited to applications, agreements,  
17 payment requests and so on, which may be necessary for the completion of the  
18 aforementioned project.




