

[Recreation and Park Department – Clubhouses and Gymnasiums.]

Ordinance amending San Francisco Park Code, Article 12, by amending Section 12.21 to increase the fees at the Clubhouses and Gymnasiums, to eliminate the reservation fee and making environmental findings.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Findings.

The Planning Department has determined that the actions contemplated in this Ordinance are in compliance with the California Environmental Quality Act (California Public Resources Code sections 21000 et seq.). Said determination is on file with the Clerk of the Board of Supervisors in File No. _____ and is incorporated herein by reference.

Section 2. The San Francisco Park Code is hereby amended by amending Section 12.21, to read as follows:

SEC. 12.21. CLUBHOUSES AND GYMNASIUMS.

(a) The following fees shall be charged for use of clubhouses:
