 - b) The view through windows shall not be constructed in any way nor shall any physical obstruction including but not limited to planters, partitions or items of décor, be placed in front of or behind or attached at or near the doors.
 - c) All doors to said studio rooms will remain unlocked and shall not have any form of locking mechanism attached at or near the doors.
 - d) The "Studio Rooms" shall be equipped with audio and video equipment sufficient for performances commonly associated with "karaoke" style entertainment.
 - e) Karaoke style entertainment must be available at all times in the rooms during the hours of operation of the premises.
- Loitering (loitering is defined as "to stand idly about; linger aimlessly without lawful business") is prohibited on any sidewalks or property adjacent to the licensed premises under the control of the licensee as depicted on the ABC-257, dated 6/13/2013.
- 8. During the hours of operation, the petitioner shall utilize a security camera system to record all entrances, exits and public areas outside of the premises. Petitioner shall retain all security recordings for at least 30 days and provide recordings to the San Francisco police Department when requested as evidence in a criminal investigation.
