3 **Resolution commending the creation of a public-private partnership between the San**  
4 **Francisco Clean City Coalition, the San Francisco Chamber of Commerce and the**  
5 **Department of Public Works (DPW) for the development of an innovative performance**  
6 **evaluation program, StreetFacts. The Board of Supervisors encourages the mayor,**  
7 **DPW, other city agencies, the San Francisco Clean City Coalition, and the San**  
8 **Francisco Chamber of Commerce to partner in the collection of StreetFacts data and in**  
9 **developing strategies towards the overall improvement of street cleanliness, beauty,**  
10 **and safety in San Francisco.**

12 WHEREAS, the San Francisco Clean City Coalition, the San Francisco Chamber of  
13 Commerce and the Department of Public Works (DPW) have partnered to improve the  
14 cleanliness and safety of San Francisco streets with a performance evaluation demonstration  
15 project called StreetFacts; and,

16 WHEREAS, StreetFacts is a street survey program based on best practices in  
17 Washington, DC, Baltimore, MD, New York City, and Seattle, WA, as well as on the  
18 technology of the Neighborhood Parks Council's ParkScan program; and,

19 WHEREAS, Volunteers from the city's established Neighborhood Beautification  
20 Advisory Committees will use hand-held computers to perform weekly surveys of the condition  
21 of San Francisco's streets, plazas, and rights of way, and will evaluate such street facets as:  
22 litter, graffiti, public trash receptacles, lighting, tree boxes and planters, building façades,  
23 sidewalks, roadways, and signage; and,

1           WHEREAS, Clean City will collect the electronic survey data, prepare survey reports,  
2 identify trends, create analysis and improvement strategies, and forward the information to  
3 DPW, other city agencies, and other appropriate venues; and,

4           WHEREAS, StreetFacts will aim to provide city leaders, DPW, and other agencies with  
5 quantifiable data that will help to identify priority areas, track improvements over time, identify  
6 sources of litter, develop strategies for remediation, and enhance current capabilities of  
7 DPW's Adopt-a-Street program; and,

8           WHEREAS, By reporting results to city leaders and to the public via the Internet,  
9 StreetFacts will improve public and private accountability for street safety and cleanliness;  
10 therefore, be it

11           RESOLVED, That That the Board of Supervisors of the City and County of San  
12 Francisco does hereby commend the San Francisco Clean City Coalition, the San Francisco  
13 Chamber of Commerce and the Department of Public Works (DPW) for partnering to create  
14 the performance evaluation program called StreetFacts, and urges the mayor, city agencies,  
15 and the public at large to support this program to improve street cleanliness, beauty, and  
16 safety in San Francisco.




