

1 [Olympic Dragon Day]

2 **Resolution declaring December 8, 2000 to be “Olympic Dragon Day” in San Francisco.**

3 WHEREAS, The City of Beijing in the People’s Republic of China is seeking to host the  
4 2008 Olympic Games; and,

5 WHEREAS, A group of Chinese Americans in the San Francisco Bay Area have  
6 organized an Alliance in Support of Beijing Olympics 2008 (“the Alliance”) to assist in Beijing’s  
7 Olympic bid; and,

8 WHEREAS, Hosting the Olympic Games will be a source of national pride to both  
9 Chinese Americans and Chinese residing in the People’s Republic of China; and,

10 WHEREAS, The Alliance is directing its efforts to publicize the work of San Francisco-  
11 based artist Zhao Jian-Hai and his dramatic earth art project scheduled to be unveiled at the  
12 Great Wall of China in May 2001; and,

13 WHEREAS, Zhao Jian-Hai’s performance art piece involves the unfurling of a 10,000  
14 meter silk-screened canvas containing two thousand eight Olympic Dragon images in what  
15 will be the longest such work in the world; and,

16 WHEREAS, The Olympic Dragon images will be held by 4,000 participants at the art  
17 piece’s unveiling; and,

18 WHEREAS, After the performance, Zhao Jian-Hai’s Olympic Dragon will be presented  
19 to the International Olympic Committee, China’s National Olympic Committee, the diplomatic  
20 community in Beijing, the Guinness Book of World Records, and sponsors; now, therefore, be  
21 it

22 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
23 hereby declares December 8, 2000 to be “Olympic Dragon Day” in San Francisco.




