18 is currently the Consulting Editor to the Rabbinical Assembly's committee on Jewish Law and
19 Standards; and

20 WHEREAS, Rabbi Leitner was installed as the new senior rabbi of Congregation Beth
21 Sholom on November 6, 2005; now, therefore, be it,
