2 AUTHORIZING THE DEPARTMENT OF PUBLIC HEALTH, POPULATION HEALTH AND  
3 PREVENTION DIVISION, COMMUNITY SUBSTANCE ABUSE SERVICES, TO ACCEPT  
4 RETROACTIVELY AND EXPEND GRANT FUNDS OF \$60,000 FROM THE SAN FRANCISCO  
5 FOUNDATION FOR A COMMUNITY PLANNING PROCESS AND TO ENTER INTO AN  
6 AGREEMENT WHICH INCLUDES AN INDEMNIFICATION CLAUSE AND DOES NOT INCLUDE  
7 PATENT INFRINGEMENT INDEMNIFICATION AND FALSE CLAIMS CLAUSES; PROVIDING  
8 FOR RATIFICATION OF ACTION PREVIOUSLY TAKEN; WAIVING INDIRECT COSTS.

9 WHEREAS, The Department of Public Health has applied for and been awarded a grant from  
10 The San Francisco Foundation in the amount of \$60,000 for a Community Planning Process to develop  
11 a strategic plan for substance abuse services; and,

12 WHEREAS, As a condition of receiving the grant funds, The San Francisco Foundation  
13 requires the City to enter into an agreement (the "Agreement"), a copy of which is on file with the  
14 Clerk of the Board of Supervisors in File No. 000237 ; and

15 WHEREAS, the Agreement contains a certain provision described below, which requires the  
16 approval of the Board of Supervisors; and

17 WHEREAS, The Agreement does not contain certain provisions described below, which are  
18 required under the Administrative Code unless waived by the Board of Supervisors ; now, therefore,  
19 be it

20 RESOLVED, That the Department of Public Health is hereby authorized to accept  
21 retroactively and expend the grant funds pursuant to San Francisco Administrative Code section  
22 10.170-1; and, be it

23 FURTHER RESOLVED, That the Director of Health is authorized to enter into the Agreement  
24 on behalf of the City; and, be it



FURTHER RESOLVED, That the Board of Supervisors hereby waives the requirement contained in Section 6.57 (c) of the Administrative Code that the Agreement include a paragraph reciting the false claim provisions contained in Section 6.57 (a) of the Administrative Code: and, be it

FURTHER RESOLVED, That the Board of Supervisors authorizes the Director of Health to enter into similar agreements with The San Francisco Foundation if the grant recurs or is renewed; and, be it

FURTHER RESOLVED, That the Board of Supervisors does hereby waive indirect costs.


