20 Section 1. Environmental Findings.

21 The Planning Department has determined that the actions contemplated in this  
22 ordinance comply with the California Environmental Quality Act (California Public Resources  
23 Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of  
24 Supervisors in File No. 211022 and is incorporated herein by reference. The Board affirms  
25 this determination.

Section 2. Authority and Role of Municipal Transportation Agency Regarding Paid Parking at the Kezar Stadium Parking Lot, and the Golden Gate Park Underground Parking Facility, ~~and the Marina Small Craft Harbor.~~

(a) Park Code Section 6.14 authorizes the Municipal Transportation Agency to identify locations suitable for the establishment of paid parking areas or zones on property under the jurisdiction of the Recreation and Park Commission, and to set rates for paid parking in such areas that are closely comparable to the rates set for similarly situated paid parking, provided, among other things, that the Board of Supervisors approves the location of the paid parking areas and the parking restrictions.

(b) In accordance with Park Code Section 6.14, the Board of Supervisors tentatively approves the implementation of paid parking with rates set by the Municipal Transportation Agency and subject to approval by the Recreation and Commission at the Kezar Stadium Parking Lot, and the Golden Gate Park Underground Parking Facility, ~~and the Marina Small Craft Harbor.~~ The Kezar Parking Lot is located at 825 Stanyan Street. The Golden Gate Park Underground Parking Facility is located under the Music Concourse area of Golden Gate Park. ~~The Marina Small Craft Harbor is located at 3950 Scott Street and encompasses those certain areas in the vicinity of and including the Marina Green.~~ The current parking rates at these facilities are adjusted for inflation but are otherwise fixed. The rates set by the Municipal Transportation Agency at those sites shall be comparable to the rates set for similarly situated parking, may increase or decrease in response to customer demand at particular times or on particular days or dates, and shall be intended to support recreation by encouraging the use of these facilities by recreational users, and by helping the Recreation and Park Department meet operating expenses, purchase or lease supplies, equipment and materials for the parks, and raise funds for future capital projects necessary to maintain

1 existing levels of service. The Board of Supervisors requests that the Municipal  
2 Transportation Agency and Recreation and Park Department provide further information  
3 regarding how the rates would be set. The rate-setting shall be finally approved and may  
4 commence after the Board of Supervisors has reviewed this information and adopted a  
5 resolution finding that the proposed rates comply with the requirements of Section 6.14.

6 (b) In accordance with Park Code Section 6.14, the Board of Supervisors approves  
7 that the parking restrictions set forth in the Park Code, as amended by this ordinance and as  
8 they may be amended in the future from time to time, shall apply to any such system of paid  
9 parking. Nothing in this ordinance may be deemed to modify or supersede the Lease dated  
10 December 24, 2004, as amended, between the Music Concourse Community Partnership and  
11 the City and County of San Francisco and the Golden Gate Park Concourse Authority, relating  
12 to the Golden Gate Park Underground Parking Facility and the debt secured by the parking  
13 facility.

14  
15 Section 3. The Park Code is hereby amended by revising Sections 6.01, 6.02, 6.10,  
16 10.01, 12.08, 12.11, and 12.35, to read as follows:

17 **SEC. 6.01. OPERATION AND PARKING OF VEHICLES.**

18 \* \* \* \*

19 (i) No person shall, in any park, allow any automobile or other vehicle to remain  
20 parked in any parking lot space which is open for public use and for which a fee is charged for  
21 parking, ~~including, but not limited to Kezar Parking Lot,~~ for a period of more than 24 hours after  
22 the expiration of the period for which a fee is charged, unless otherwise allowed by permit.

24 (k) No person shall, in any park, allow any automobile or any other vehicle that is  
25 disabled to remain parked in any parking lot space which is open for public use and for which a

1 fee is charged for parking, ~~including but not limited to Kezar Parking Lot,~~ unless otherwise  
2 allowed by permit.

3 (l) No person shall, in any park, commit any of the offenses listed in Sections 302 and  
4 303 of Division II of the Transportation Code, as they may be amended from time to time.

5  
6 **SEC. 6.02. TOWING OF VEHICLES.**

7 (a) Whenever any ~~member/officer~~ of the ~~San Francisco~~ Police Department, ~~employee of~~  
8 ~~the San Francisco Municipal Transportation Agency (SFMTA), or~~ employee or lessee authorized  
9 by the Recreation and Park Department or Commission finds any vehicle parked in violation  
10 of Sections 6.01(d), (e), (f), (g), (h), (i), (j), or (k) of this Code, such officer, employee, or  
11 lessee may provide for the removal of such vehicle, so long as signs have been posted to  
12 inform the public that vehicles so parked are subject to removal and, with respect to Section  
13 6.01(i), so long as there is an attendant on duty or other facilities permitting the patron to pay  
14 or remit the parking charges at the time the vehicle is first parked.

15 (b) The procedure for removal and impounding of vehicles shall be as is provided for  
16 in applicable provisions of the ~~San Francisco Transportation Traffic~~ Code and Sections 22850 to  
17 22855 of the California Vehicle Code.

18 (c) ~~Moreover, a~~Any vehicle stopped, parked, or left standing in such a manner as to  
19 violate Sections 6.01(d), (e), (f), (g), (h), (i), (j), or (k) of this Code is an obstruction to the free  
20 use of property and a nuisance within the meaning of Part III of the Civil Code of California  
21 relating to nuisances and the abatement thereof.

22  
23 **SEC. 6.10. PENALTIES.**

24 (a) A person who commits an offense listed in Sections 302 or 303 of Division II of the  
25 Transportation Code shall be required to pay the fines specified in those Sections. Otherwise,

1 a A person who violates Section 6.01(c), (d), (e), (f), or (g) of this Code shall be guilty of an  
2 infraction and upon conviction thereof shall be punished for the first offense by a fine not to  
3 exceed \$50; for the second offense committed within a one-year period by a fine not to  
4 exceed \$100; for a third and each additional offense committed within a one-year's period by a  
5 fine not to exceed \$250.

6 (b) This Section 6.10 shall not be deemed to contradict Section 6.02 of this Code  
7 concerning the towing of vehicles in violation of Section 6.01(d), (f), or (g). ~~Not shall this~~  
8 ~~Section 6.10 contradict or limit the ability of SFMTA to establish and impose fines and~~  
9 ~~penalties pursuant to the Transportation Code for parking violations on park property, subject~~  
10 ~~to the approval of the Recreation and Park Commission.~~

18 **SEC. 12.08. PARKING FEES ON RECREATION AND PARK PROPERTY.**

19 (a) The following fees shall be charged for parking at the Kezar Parking Lot. The rates for  
20 parking at the Kezar Stadium Parking Lot may be set by the San Francisco Municipal Transportation  
21 Agency (SFMTA) in accordance with Section 6.14. Until such time as the SFMTA has set rates with  
22 approval of the Recreation and Park Commission and the Board of Supervisors, the rates, which are  
23 subject to annual adjustment under Section 12.20, shall continue to apply:

(a) The rates to be charged for parking in the Golden Gate Park Underground Parking Facility may be set by the SFMTA in accordance with Section 6.14. Until such time as the SFMTA has set rates with approval of the Recreation and Park Commission and the Board of Supervisors, the rates, which are subject to annual adjustment under Section 12.20, shall continue to apply ~~be as follows:~~

Section 4. Effective Date. This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor’s veto of the ordinance.

Section 5. Future Updates to Park Code Sections 12.08 and 12.35. Park Code Sections 12.08(a) and 12.35(a) contain rates previously approved by the Board of Supervisors for parking at the Kezar Stadium Parking Lot and Golden Gate Park Concourse Underground Parking Facility. This ordinance approves of the San Francisco Municipal Transportation Agency (SFMTA) setting new parking rates at those facilities with the approval of the Recreation and Park Commission and the Board of Supervisors, but the rate-setting and approvals have not yet occurred, so the existing rates in the Park Code, adjusted in

1 accordance with Park Code Section 12.20, shall continue to apply in the interim. The  
2 Recreation and Park Department is directed to notify the City Attorney’s Office in writing once  
3 SFMTA has commenced setting rates at those facilities with approval of the Recreation and  
4 Park Commission and the Board of Supervisors. Upon receiving such notice, the City  
5 Attorney’s Office shall cause Sections 12.08 and 12.35 to be revised accordingly.

6  
7 Section 6. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors  
8 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,  
9 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal  
10 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment  
11 additions, and Board amendment deletions in accordance with the “Note” that appears under  
12 the official title of the ordinance.

**REVISED LEGISLATIVE DIGEST**  
(Amended in Committee, 11/10/2021)

[Park Code - Parking Fees and Fines, Park Patrol Enforcement]

**Ordinance authorizing the Municipal Transportation Agency (SFMTA) to set parking rates at the Kezar Stadium Parking Lot and Golden Gate Park Underground Parking Facility in accordance with Park Code provisions that authorize SFMTA rate-setting on park property and subject to Board of Supervisors approval, and making conforming edits to the Park Code; increasing parking rates for berth-holders at the Marina Small Craft Harbor; clarifying that the fines for certain violations of the Transportation Code apply to similar violations occurring on park property; clarifying the authority of Park Patrol to enforce the Park Code and issue parking citations; and affirming the Planning Department's determination under the California Environmental Quality Act.**

Existing Law

Rates for parking by the general public at the Kezar Parking Lot and Golden Gate Park Underground Parking Facility are set in the Park Code. The Park Code rates are adjusted annually for inflation but are otherwise fixed. Under Park Code Section 6.14, however, the San Francisco Municipal Transportation Agency (SFMTA) may take over setting parking rates at designated locations on park property, subject to certain approvals by the Board of Supervisors and Recreation and Park Commission, and set rates that are closely comparable to the rates for similarly situated paid parking. The Park Code also sets parking rates for persons who hold licenses to berth vessels at the Marina Small Craft Harbor: berthholders get two free parking passes with their berthing licenses, and can purchase additional passes for \$156 each.

Amendments to Current Law

The ordinance would allow SFMTA, with Recreation and Park Commission approval, to set new rates for parking by the general public at the Kezar Parking Lot and Golden Gate Park Underground Parking Facility. The proposal is for SFMTA to be able to set the rates, and for SFMTA to be able to increase or decrease the rates in response to customer demand at particular times or on particular days or dates, provided that the rates must be intended to support recreation and must be closely comparable to the rates set for similarly situated parking. The ordinance would require SFMTA and the Recreation and Park Department (RPD) to provide further information to the Board of Supervisors about the rates that SFMTA would set at those facilities and how they would increase or decrease over time. If the Board then found by resolution that the rates meet the requirements of Section 6.14, the SFMTA rate-setting could go into effect, and the existing Park Code rates for parking at those facilities would cease to apply. Meanwhile, the Park Code rate for Marina berthholders to purchase additional parking passes would increase to \$600.

The ordinance also clarifies existing law, by expressly stating that the penalties for certain violations of the Transportation Code (e.g., parking in a disabled spot) apply equally when those violations occur on park property, and by affirming the authority of the Park Patrol to issue citations for Park Code violations.

### Background

The ordinance was originally introduced in Board File No. 210654. On September 22, 2021, the Budget and Finance Committee made certain amendments as described in the legislative digest (v2), and duplicated the file. On November 3, 2021, the Committee reviewed and amended the ordinance in the duplicated file, to 1) condition the SFMTA's rate-setting at the Kezar Parking Lot and Golden Gate Park Underground Parking Facility on the Board of Supervisors' further review and approval of the rates; 2) clarify that the fines for certain violations of the Transportation Code apply to similar violations occurring on park property; and 3) clarify the authority of Park Patrol to enforce the Park Code and issue parking citations.



The Sunset-Parkside Education and Action Committee (SPEAK) is a 501(c)3 organization which has been an active voice in the Sunset-Parkside district for over 50 years. We represent residents in this area that borders Ocean Beach and Golden Gate Park.

We oppose the proposal by the GGNRA to charge for parking at various nearby national parks in San Francisco.

The GGNRA has proposed to charge \$3.00 an hour to park a car to visit these parks with a maximum charge of \$10. We support our parks, but we also support access to our parks by San Francisco residents. This fee will discourage San Franciscans from coming to these parks to enjoy the magnificent ocean views, to experience wildlife in a natural setting, and to get a respite from the stresses of urban life, made even more difficult during the COVID pandemic.

We also wonder why there have been no public notices posted in the proposed fee areas. At any time, but especially during the COVID pandemic, it is vital that government agencies make every effort to inform the public of any proposed changes that will impact access to their public lands. Notices should be posted at all of the proposed fee locations, and the comment period should be extended 30 days from the posting of the notices.

According to the GGNRA website,

*"The proposal calls for parking fees to be in effect at these locations between 8 a.m. and 5 p.m., which means that people visiting outside these hours would not be charged for parking. Many visitors to the park travel by bicycle or foot, and public transit which operates in close vicinity to many of the affected parking lots, including Stinson Beach, Lands End and Baker Beach, offers an inexpensive alternative to driving."*

Let's unpack this statement.

1. It is accompanied by a photo of a healthy, relatively young person on a bicycle. However, the majority of people in SF do not bike from one end of the city to the other because of various reasons -- disabilities, dangerous streets, the cost of a good bicycle, and due to the hilly nature of the City - a bicyclist has to be in good shape to get around.

2. "People visiting outside [the hours of 8 a.m. and 5 p.m.] would not be charged for parking." It gets dark at 5:00 p.m. during the winter months and the sun at times does not rise until 7:30 a.m. So the public might have ½ hour in the early morning to park for free. And really, how many families visit parks in the early morning or in the evening?
3. Bus service in San Francisco has been severely curtailed during COVID. It is not clear when it will recover or which lines will survive.
4. Many people still do not want to expose their health to others on a bus.
5. Parking fees will also limit access for residents from the southeastern part of San Francisco, who may have to drive to these areas - especially families with small children. Many are lower-income. They deserve the opportunity to enjoy parkland without impediments such as fees. And riding MUNI will cost at least as much as the parking, for 2 adults. It is not an 'inexpensive' alternative. (These families may already own cars to get their children to school and other events and to drive to work.)
6. MUNI service is not back to full service, due to COVID. Even when - and if - MUNI service is restored, being forced to go across town by bus is going to make park visitation more difficult for most San Francisco residents.
7. Charging fees at the GGNRA lots will force residents to park in the lots at Ocean Beach, filling up those lots and further limiting access. These fees set a precedent for charging San Franciscans for access to our beaches. Fees may spread to other park sites, including City parks such as Ocean Beach.

We therefore oppose these fees and ask you to discontinue this proposal.
