9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The City Attorney is hereby authorized to settle the action entitled "The

12 and Lydia Collins," San Francisco Superior Court, Case No. PES-04-285738" by the receipt
13 by Lydia Collins of \$20,000 directly from the De Young Museum's beneficial share of the
14 residue of the estate, and \$20,000 directly from the Steinhart Aquarium's beneficial share of
15 the residue of the estate. No payment shall be made by the City and County of San
16 Francisco.

17 Section 2. The above-named petition was filed in the San Francisco Superior Court on
18 August 20, 2004, and the following parties were named in the action: Petitioner: City and
19 County of San Francisco; Respondents: Gregory P. O'Keeffe and Lydia Collins.
