8 Section 1. The City Attorney is hereby authorized to settle the portion of the action

10 Superior Court, Court No. 436930, as it relates only to plaintiff Sally Seid, by the payment of
11 \$48,500, and excluding the claim by this plaintiff for diminution of property value, attorney's
12 fees, costs and interest, which will be addressed in later proceedings.

13 Section 2. The above-named action was filed in San Francisco Superior Court on
14 January 31, 2005, and the following settling parties were named in the lawsuit: Plaintiff Sally
15 Seid and Defendant City and County of San Francisco.
