3 **Resolution determining that the premise to premise transfer of a Type 48 on-sale**  
4 **general public premises liquor license from 101 - 6th Street to expansion of**  
5 **public occupancy into basement storage at 101 - 6th Street (District 6), to Mark E.**  
6 **Rennie for Playbar, Inc., dba The Room, will serve the public convenience or**  
7 **necessity of the people of the City and County of San Francisco, in accordance**  
8 **with Section 23958.4 of the California Business and Professions Code, with**  
9 **conditions.**

11 WHEREAS, Mark E. Rennie is seeking a transfer of a Type 48 on-sale general  
12 public premises liquor license from 101 - 6th Street to expansion of public occupancy  
13 into basement storage at 101 - 6th Street for Playbar, Inc., dba The Room; and,

14 WHEREAS, The Planning Department has verified that the area is properly  
15 zoned and recommends approval; and,

16 WHEREAS, The Police Department recommends that the liquor license  
17 application be approved with conditions; now, therefore, be it

18 RESOLVED, That in accordance with Section 23958.4 of the California Business  
19 and Professions Code, the Board of Supervisors of the City and County of San  
20 Francisco hereby determines for the foregoing reasons that the transfer of a Type 48  
21 on-sale general public premises liquor license from 101 - 6th Street to expansion of  
22 public occupancy into basement storage at 101 - 6th Street to Mark E. Rennie for 1  
23 Playbar, Inc., dba The Room, will serve the public convenience or necessity of the  
24 people of the City and County of San Francisco.

1           Conditions: (1) The sales, service, and consumption of alcoholic beverages  
2 shall be permitted only between the hours of 2:00 p.m. and 2:00 a.m. each day of the  
3 week on the main (ground) floor. The lower floor (basement level) shall permit the  
4 sales, service, and consumption of alcoholic beverages Sunday through Wednesday  
5 2:00 p.m. to 1:00 a.m. and 2:00 p.m. to 1:45 a.m. Thursday, Friday, and Saturday. The  
6 lower floor (basement level) may sell, service, and allow consumption of alcoholic  
7 beverages from 2:00 p.m. to 2:00 a.m. on New Year's Eve, Christmas Eve,  
8 Thanksgiving Eve, the Fourth of July, and the Sunday before Labor Day and Memorial  
9 Day only. (2) No noise shall be audible beyond the area under control of the licensee.  
10 (3) The sales, service and consumption of alcoholic beverages shall remain within the  
11 confines of the area depicted on the ABC form 257. (4) The sale of alcoholic  
12 beverages for consumption off the premises is strictly prohibited. (5) Petitioner shall  
13 not permit its patrons or the general public to loiter or congregate on the sidewalks  
14 adjacent to the licensed premises. The orderly standing of patrons in line to enter the  
15 premises shall not be considered loitering or unlawfully congregating. (6) Petitioner  
16 shall not make structural changes in the premises interior without prior written approval  
17 from the Department.

This office represents Playbar, Inc. dba **The Room**. My clients have applied to the California Department of Alcoholic Beverage Control (ABC) for a premise to premise transfer of their On-Sale General Public Premises license. This premise to premise transfer is to allow applicant to operate and sell alcohol beverages to the public in the basement area of the premises at 101-6<sup>th</sup> Street, San Francisco. My client's presently have a type-48 on-sale general ABC license on the premises. The basement is presently shown on the Diagram of Licensed Premise, however, this portion of the premises is listed for storage and office use only. My client has received a Certificate of Occupancy from the SF Department of Building Inspection and the SF Fire Department to allow use of the basement for public occupancy. This request is to allow the expansion of its ABC license privilege to allow the of selling of alcoholic beverages to the public in the basement area Playbar, Inc. dba The Room.

**The Room** has operated at this location since 2005. It is a good neighbor and has hosted numerous fundraising events and nonprofit benefits. It has also hosted many community meetings. The Room holds a valid Place of Entertainment license on the premises which allows them to provide live and DJ music to their patrons until 2 am. This Place of Entertainment allows entertainment to occur on both the first floor and basement levels of the establishment.

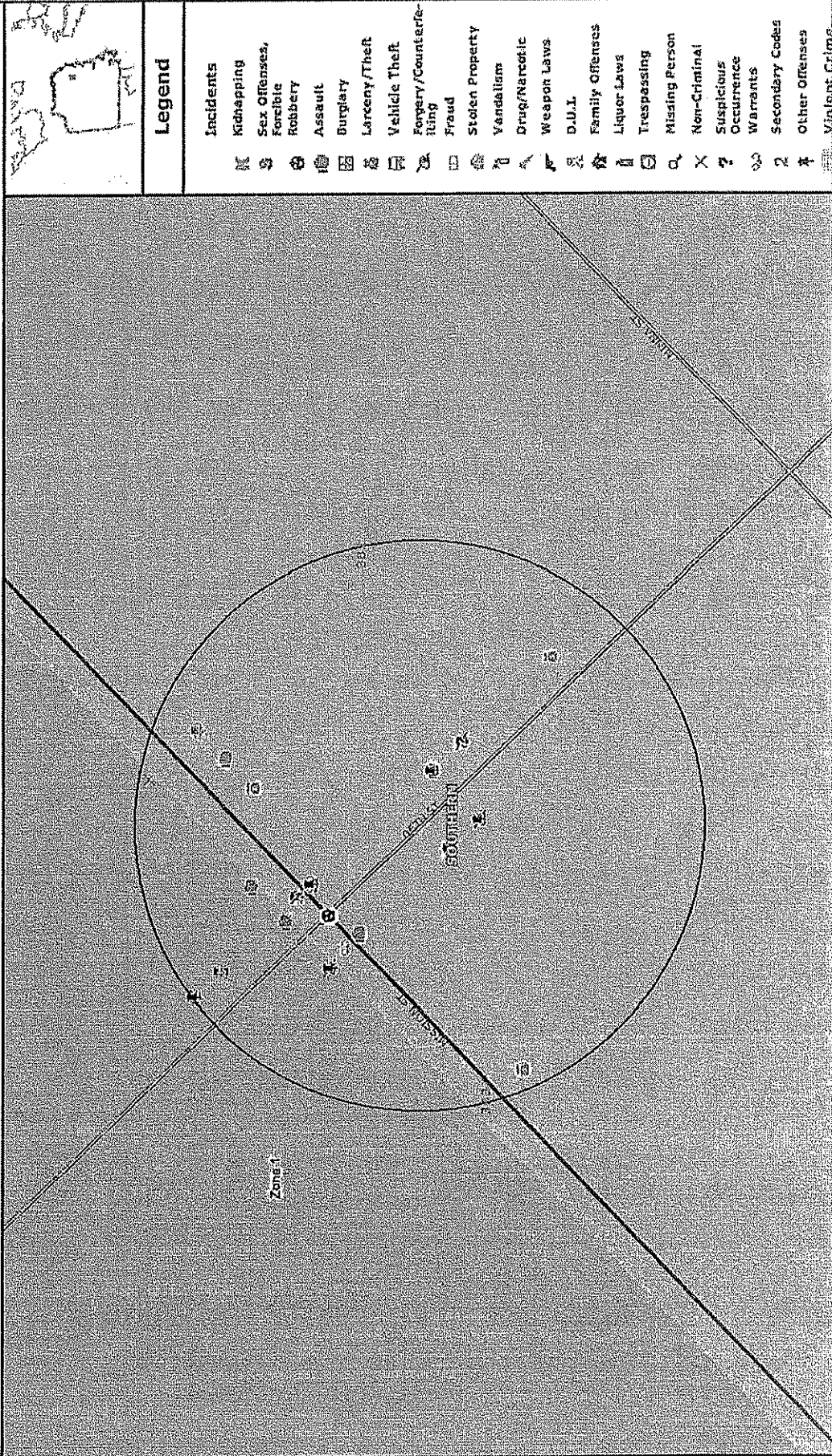

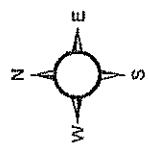
