3 **Resolution enacting and rescinding parking regulations at various locations.**

5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code  
6 and the San Francisco Traffic Code, the following regulations governing the parking of  
7 vehicles are hereby enacted or rescinded as designated below:

8 **PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH**

9 Rhode Island Street, east side, from 17th Street to 190 feet northerly.

10 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

11 Bayshore Boulevard, west side, from Industrial Street to Silver Avenue (to allow  
12 installation of bicycle lanes).

13 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

14 49-51 and 55 Norfolk Street, between the driveways of 49-51 and 55 Norfolk Street  
15 (12-foot space accommodating 2 motorcycle spaces).

16 **RESIDENTIAL PERMIT PARKING AREA "I" (1-HOUR TIME LIMIT, 9 AM - 6 PM, MONDAY**  
17 **THROUGH SATURDAY) - ESTABLISH**

18 2700 and 2730 Mission Street, between 23rd and 24th Streets (adds specific addresses  
19 only, no signs will be posted on this block).

20 **RESIDENTIAL PERMIT PARKING AREA "J" (2-HOUR TIME LIMIT, 8 AM - 5 PM,**  
21 **MONDAY THROUGH FRIDAY) - ESTABLISH**

22 Moraga Street, both sides, between 12th Avenue and Funston Street (600 Block).

23 **2-HOUR PARKING TIME LIMIT, 9 AM TO 6 PM, EXCEPT SUNDAY - ESTABLISH**

24 Kansas Street, east side, between 16th and 17th Streets (300 Block).

Kansas Street, east side, between 16th and 17th Streets (300 Block).


