RE: 2025 Departmental Overdose Prevention Policies

Dear Honorable Members of the Board of Supervisors:

Attached for your consideration is a Resolution acknowledging receipt of the 2025 Departmental Overdose Prevention Policies for the Department of Public Health (DPH), the Department of Homelessness and Supportive Housing (HSH), the Department of Emergency Management (DEM), and the Human Services Agency (HSA).

Administrative Code, Section 15.17, requires each department listed above to annually submit, beginning in 2021, to the Board of Supervisors a departmental policy describing how the department and its grantees that provide direct services to clients who use drugs will promote strategies to reduce drug overdoses ("Overdose Prevention Policy"). The 2021, 2022, 2023, and 2024 Departmental Overdose Prevention Policies are on file with the Clerk of the Board in legislative files 211304, 221275, 231276, and 250018 respectively.


