

1 [Acceptance Of Gift]

2 AUTHORIZING THE CITY LIBRARIAN TO ACCEPT A GIFT OF AN ONGOING INCOME
3 INTEREST IN THE FRITZ AND LILLIAN DANNENBERG LIBRARY FUND FOR THE SAN
4 FRANCISCO PUBLIC LIBRARY.

6 WHEREAS, The San Francisco Public Library ("Library") is in need of funds; and,

7 WHEREAS, The late Lillian Dannenberg most generously and graciously directed in
8 her will, dated April 28, 1995, that 70% of the residue of her estate be distributed to the
9 Library Foundation of San Francisco (the "Foundation") and held in a restricted fund called
10 "The Fritz and Lillian Dannenberg Library Fund" (the "Dannenberg Fund");

11 WHEREAS, The late Lillian Dannenberg also directed in her will that all of "the net
12 income from the Dannenberg Fund is to be given by the Library Foundation to the Library with
13 such income to be expended by the Library solely for the purchase of books, periodicals, and
14 other materials, audio or visual, on the subject of German or Italian Literature, in translation
15 and/or in original language, and English books, periodicals, and other materials, audio or
16 visual, containing the historical background and the progress and advancement of the
17 German and Italian-American Citizens in America";

18 WHEREAS, The Foundation established the Fritz and Lillian Dannenberg Library Fund
19 in 1996 and such fund has earned approximately \$8000 per year in interest; and,

20 WHEREAS, In order for the Library to be able to use such income interest to purchase
21 the types of materials described in Mrs. Dannenberg's bequest, the Foundation must transfer
22 the income generated from the Dannenberg Fund to the Library; now, therefore, be it


