Dear Mr. Corpuz:

Thank you for your correspondence in regards to the liquor license public necessity or convenience request for Board of Supervisors File No. 150218. The Clerk of the Board of Supervisors did not receive official correspondence through the United States Post Office from the California Department of Alcoholic Beverage Control (ABC). However, we received an email from the San Francisco Police Department of a fax sent to the Police Department from ABC requesting clarification on the City's position.

The Board of Supervisors Public Safety and Neighborhood Services tabled the item on May 21, 2015, and later filed the matter on July 17, 2015, not moving forward with an affirmative stance on the item. In the absence of approval or rejection of a finding of public convenience or necessity, ABC has the authority to make a determination, pursuant to Business and Professions Code, Section 23958.4 (b)(2), in that if a local governing body, or its designated subordinate officer or body, does not make a determination within the 90-day period, then the department (ABC) may issue a license if the applicant shows the department that public convenience or necessity would be served by the issuance.


