9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Kevin Lee v. City and County of San
12 Francisco et al., San Francisco Superior Court, Case No. CGC-19-580969 by the payment of
13 \$35,000. The lawsuit involves an employment dispute.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 November 22, 2019, and the following parties were named in the lawsuit: Plaintiff: Kevin Lee;
