3 **Ordinance authorizing settlement of the lawsuit filed by Javier Grajeda against the City**  
4 **and County of San Francisco for \$30,000; the lawsuit was filed on April 6, 2021, in San**  
5 **Francisco, Case No. CGC-21-590836; entitled Javier Grajeda v. City and County of San**  
6 **Francisco, et al.; the lawsuit involves alleged personal injury from vehicle collision and**  
7 **an associated workers' compensation lien.**

8  
9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Javier Grajeda v. City and County of  
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-21-590836 by the  
13 payment of \$30,000, divided as follows: (1) \$20,000 to Javier Grajeda and (2) \$10,000 to  
14 Amguard Insurance Company arising from the workers' compensation lien. The lawsuit  
15 involves alleged personal injury from vehicle collision and an associated workers'  
16 compensation benefits lien.

17 Section 2. The above-named action was filed in San Francisco Superior Court on April  
18 6, 2021, and the following parties were named in the lawsuit: Plaintiff Javier Grajeda,  
19 Defendants John George Ford, City and County of San Francisco, and State of California and  
20 Plaintiff in Intervention Amguard Insurance Company.
