10 Be it ordained by the People of the City and County of San Francisco:


11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby

14 San Francisco Superior Court, Case No. CGC-14-543173 by the payment of \$273,853.76 by


