3 **Resolution retroactively authorizing Public Works to accept and expend an increased**  
4 **amount of \$226,265.50 for a total grant amount of \$3,015,619.50 from the United States**  
5 **Department of Transportation Federal Highway Administration Federal Emergency**  
6 **Relief Program to fund the construction of the Public Works' O'Shaughnessy**  
7 **Boulevard Emergency Relief project for the period of September 23, 2019, through**  
8 **June 30, 2025.**

10 WHEREAS, On January 19, 2017, the Director of San Francisco Public Works issued  
11 DPW Order No. 185632 declaring a local emergency as to the severe erosion of  
12 O'Shaughnessy Boulevard; and

13 WHEREAS, On January 23, 2017, the Governor of California proclaimed that the  
14 California Department of Transportation (Caltrans) request immediate assistance through the  
15 Federal Highway Administration's Emergency Relief Program, Title 23, United States Code,  
16 Section 125, in order to obtain federal assistance for highway repairs or reconstruction for the  
17 damages and erosion resulting from a storm system; and

18 WHEREAS, San Francisco Public Works (SFPW) applied to Caltrans and received  
19 approval for O'Shaughnessy Boulevard to receive \$2,789,354 in federal funds; and

20 WHEREAS, On May 8, 2018, the City and County of San Francisco Board of  
21 Supervisors adopted Resolution No. 138-18, and is incorporated herein by reference; and

22 WHEREAS, On May 17, 2018, Mayor Mark Farrell signed Resolution No. 138-18 which  
23 retroactively authorized the Director of Public Works to accept and expend an amount not to  
24 exceed \$2,789,354 from the United States Department of Transportation Federal Highway  
25 Administration Federal Emergency Relief Program for the O'Shaughnessy Boulevard

1 Emergency Relief project; and

2 WHEREAS, On September 23, 2019, San Francisco Public Works received  
3 authorization for the Permanent Restoration construction phase of work which included a  
4 \$226,265.50 increase to the total grant amount; and

5 WHEREAS, The funding does not require an ASO amendment; and

6 WHEREAS, The additional budget does not increase the project's indirect costs; and

7 WHEREAS, The Department proposes to maximize use of additional grant funds on  
8 program expenditures by not including indirect costs; and

9 WHEREAS, SFPW allocated local matching funds; now, therefore, be it

10 RESOLVED, That this Board of Supervisors authorizes SFPW to accept and expend  
11 an additional \$226,265.50 bringing the total grant amount to \$3,015,619.50 for the project  
12 described above; and, be it

13 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
14 indirect costs in the additional grant budget; and, be it

15 FURTHER RESOLVED, That the Director of Public Works or his or her designee is  
16 authorized to execute all required documents for receipt of Emergency Relief Program funds.

An **Emergency** exists as a result of a rock slide on January 10, 2017, along O'Shaughnessy Boulevard between Del Vale Avenue and Malta Drive. ARUP/RYCG, the on-call geotechnical engineering consultants have concluded that the slope must be scaled in a controlled manner to mitigate any falling hazard to pedestrians, bicyclists and motorists on O'Shaughnessy Boulevard. This condition constitutes an emergency involving the health, safety and property of the citizens of the City & County of San Francisco.

Therefore, in order to move forward with the project before the start of the winter season, **an Emergency is declared to exist** under the provisions of Section 6.60 of the San Francisco Administrative Code, and

is hereby awarded a contract to provide the necessary construction work for the affected rock face at a cost not to exceed **\$52,000.00**.

Contractor shall indemnify and hold harmless the City & County of San Francisco, its officers, agents and employees and furnish certificates of insurance protecting Contractor, any sub-contractors and the City & County of San Francisco and its officers, agents and employees against claims arising out of work performed pursuant to this order with the City & County of San Francisco, its officers, agents and employees named as additional insureds. Contractor shall deliver certified copies of the certificates of insurance within three working days of this order.

**Commercial General Liability Insurance** with limits not less than \$1,000,000 each occurrence, and \$2,000,000 general aggregate, combined single limit for bodily injury and property damage, including coverage for contractual liability, independent contractors, explosion, collapse and underground (XCU), personal injury, broadform property damage and completed operations.

**Commercial Automobile Liability Insurance** with limits not less than \$1,000,000 each occurrence combined single limit for bodily injury and property damage, including owned, hired or non-owned vehicles, as applicable.

**Workers' Compensation**, in statutory amount, including Employers' Liability coverage with limits not less than \$1,000,000 each accident, injury or illness.



Contractor is notified that in the event that Contractor employs professional engineering or land surveyor services for performing field engineering or preparing design calculations, plans and specifications, Contractor shall require the retained engineers and land surveyors to carry professional liability insurance with limits not less than \$1,000,000 each claim with respect to negligent acts, errors or omissions in connection with professional services to be provided under the subject Contract.

We are pleased to notify you that the Authorization to Proceed to construction has been approved for the above-referenced federal aid project. A copy of the authorization document (E-76) is attached for your files. The effective date of approval is 9/23/2019.

You should refer to Chapter 15 of the Local Assistance Procedures Manual (LAPM) at <https://dot.ca.gov/programs/local-assistance/guidelines-and-procedures/local-assistance-procedures-manual-lapm> that sets forth the procedures for project advertisement and award of the construction contract.

After advertising the project for bids, please send us one copy of the "as advertised" plans and special provisions. A minimum 21-day advertisement period is required for all projects. Any addenda must be approved by your agency and documented in your project files. LAPM's Exhibits 15-C and 15-I checklists will be helpful during this period and should be placed in your project file. You should award the contract to the lowest responsive and responsible bidder. If award is not to the lowest bidder, you must provide written documentation in your files. Remember federal law prohibits local preferences to bidders as well as requiring any bidder to obtain a license before submitting a bid. The contractor must have a valid State contractor's license for award of the contract. The Form FHWA-1273 must be physically incorporated into the construction contract, subcontracts and lower-tier subcontracts; referencing Form

FHWA-1273 separately or as part of project's other contract document(s) is not acceptable. Immediately after award of the contract and prior to the first invoice of the construction phase you must submit a copy of the following information as one package to the District Area Engineer:

- The Local Agency Contract Award Checklist (Exhibit 15-L)
- Detail Estimate (Exhibit 15-M)
- Resident Engineer's Construction Contract Administration Checklist (Exhibit 15-B)
- Low Bidder's Proposal
- Local Agency Bidder DBE Commitment (Construction Contracts) (Exhibit 15-G)
- If DBE Goal is not attained, "DBE Information-Good Faith Efforts" (Exhibit 15-H) filled out by the contractor and the agency's "Evaluation of Good Faith Effort" Memorandum (Exhibit 9-E)
- Bid Tabulation Summary Sheet (Exhibit 15-D)

A sample award transmittal letter is attached to help you in reporting the above documents. Failure to submit complete and accurate project documentation may result in the de-obligation of funds on this project.

In addition to above award package submittal, immediately after issuing a Notice to Proceed to the contractor, e-mail a copy of the notice to your Agency's Area Engineer, jimmy.panmai@dot.ca.gov, and Construction Oversight Engineer, siobhan.saunders@dot.ca.gov.

It is imperative that records for this project are clear, well organized, up to date, and complete. All contract documentation and backup records shall be available at any time for inspection by Caltrans and FHWA reviewing personnel. Use of a uniform project filing system, together with diligent maintenance of the system, greatly facilitates a process review and minimizes negative findings. The project files should be available at a single location. An example of a **Project Record Filing System** for locally administered Federal-aid projects can be found in Section 16.8 of the LAPM. Please note that material sampling and testing requirements must follow your approved Quality Assurance Program per Section 16.14 of the LAPM.

**Any unforeseen or additional work to be added to the contract must be within the project scope/limits as defined in the approved NEPA document and the Right of Way Certification regardless of its funding sources. ### Summary

San Francisco Public Works (SFPW) requests retroactive authorization to accept and expend \$226,265.50 from the United States Department of Transportation Federal Highway Administration Federal Emergency Relief Program to fund the construction of the Public Works' O'Shaughnessy Boulevard project. This authorization will bring the total grant amount to \$3,015,619.50.

On May 17, 2018, Mayor Mark Farrell signed Resolution no. 138-18 which retroactively authorized the Director of Public Works to accept and expend an amount not to exceed \$2,789,354 from the United States Department of Transportation Federal Highway Administration Federal Emergency Relief Program for the O'Shaughnessy Boulevard project. On May 17, 2018, SFPW entered into a Program Supplement Agreement with Caltrans for the O'Shaughnessy Boulevard project. The project is divided into three phases of work, with two Emergency Opening phases that start immediately after the emergency and one Permanent Restoration phase that requires authorization to proceed from Caltrans.

On September 23, 2019, San Francisco Public Works received authorization to proceed with construction from Caltrans, which included a \$226,265.50 fund increase, bringing the total grant amount for all phases to \$3,015,619.50.

### Background

On January 19, 2017, San Francisco Public Works issued Order No. 185632 declaring a local emergency regarding the severe erosion on O'Shaughnessy Boulevard, resulting from a storm system.

On January 23, 2017, Governor of California, Jerry Brown, proclaimed that a storm system resulting from an atmospheric river, combined with extreme drought conditions, caused dangerous flash flooding, erosion, and substantial mud and debris flows throughout the State of California. The Governor directed the California Department of Transportation (Caltrans) to request immediate assistance through the Federal Highway Administration's Emergency Relief Program in order to obtain federal assistance for highway repairs and reconstruction for the damages and erosion resulting from a storm system.

The Emergency Relief Program allows local agencies to start work immediately after the emergency and seek reimbursement from Caltrans at a later date. Once Caltrans received the authority to use federal Emergency Relief Program funds for damages resulting from the storm, San Francisco Public Works requested and was approved to receive \$2,789,354 in federal funds. The initial damage assessment allows up to \$3,015,619.50 in total federal reimbursement, pending completion of design and updating cost estimates for the construction phase.

On May 17, 2018, Mayor Mark Farrell signed Resolution no. 138-18 which retroactively authorized the Director of Public Works to act as the agent of the City and County of San Francisco, as a non-state agency, to accept and expend federal financial assistance under Public Law 93-288, as amended by the Robert T. Stafford Disaster Relief and Emergency Assistance Act of 1988, from the United States Department of Transportation Federal Highway Administration, and/or state financial assistance under the California Disaster Assistance Act, for an amount not to exceed \$2,789,354 to reimburse the local funds used to cover the 2017 emergency response costs and pay for the federal share of the permanent restoration to address the emergency condition of the severe erosion along O'Shaughnessy Boulevard.
