

1 [Rehabilitation of Gay Victims Under the National Socialist Government]

2 **URGING THE FEDERAL REPUBLIC OF GERMANY TO ANNUL THE SENTENCES OF ALL**
3 **INDIVIDUALS, PARTICULARLY GAY AND LESBIAN INDIVIDUALS, WHO WERE**
4 **CONVICTED UNDER THE REICH PENAL CODE SECTION 175 AND 175A BY THE**
5 **NATIONAL SOCIALIST JUDICIARY BETWEEN 1935 AND 1945 AND FURTHER TO**
6 **INCLUDE GAY, LESBIAN, BISEXUAL AND TRANSGENDER COMMUNITIES AMONGST**
7 **THOSE GROUPS ENTITLED TO RECOGNITION AND FULL COMPENSATION AS VICTIMS**
8 **OF THE NATIONAL SOCIALIST GOVERNMENT AND FURTHER TO PUBLICLY**
9 **APOLOGIZE FOR ALLOWING THE 1935 VERSION OF THE REICH PENAL CODE**
10 **PARAGRAPH 175 TO REMAIN UNCHANGED UNTIL 1969 .**

11 WHEREAS, In 1935, the National Socialist Judicial System amended the provisions of
12 the criminal code to define any sexual conduct between men as a crime including covetous
13 looks; and

14 WHEREAS, From 1935 to 1945, the Nazi judiciary convicted over 50,000 people for the
15 "crime" of homosexuality and to this day those individuals who have survived the holocaust
16 have no received just compensation from the German government; and

17 WHEREAS, In June 1998, the German Bundestag passed legislation to annul unjust
18 sentences imposed during the National Socialist Administration of Criminal Justice; and

19 WHEREAS, However the legislation excluded two groups: homosexuals and deserters;
20 and

21 WHEREAS, The exclusion of gay victims from eligibility of annulment criminal
22 sentences imposed by the National Socialist Judiciary constitutes blatant discrimination of gay
23 and lesbian victims who suffered cruel injustices perpetrated by the Nazi regime; now

1 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
2 hereby urges the Federal Republic of Germany to annul the sentences of all individuals,
3 particularly gay and lesbian individuals, who were convicted under the Reich Penal Code
4 section 175 and 175A by the National Socialist Judiciary between 1935 through 1945; and be
5 it

6 FURTHER RESOVLED, That the Board of Supervisors urges the Federal Republic of
7 German to include gay, lesbian, bisexual and transgender communities amongst those entitled
8 to recognition and full compensation as victims of the National Socialist Government; and

9 FURTHER RESOVLED, That the Board of Supervisors urges the Federal Republic of
10 German to apologize for allowing the 1935 version of the Reich Penal Code Paragraph 175 to
11 remain unchanged until 1969; and

12 FURTHER RESOVLED, That the Board of Supervisors requests the Clerk of the Board,
13 upon passage of this resolution, send a copy of this resolution to the German Ministry of
14 Justice and the German Parliament Committee on Justice:


