12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. Article 1, Section 41.25 of the San Francisco Health Code is hereby  
14 amended to read as follows:

15 **SEC. 41.25. PENALTIES.**


16 (a) ~~Any person violating~~ violation of the provisions of Section 41.21 of this Article shall  
17 be ~~deemed guilty of~~ a misdemeanor, and ~~upon conviction thereof shall be~~ punishable by a fine of  
18 not more than \$500.

19 (b) ~~Any person violating~~ violation of the provisions of Section 41.15, ~~41.18(e)~~ or 41.19  
20 of this Article shall be ~~deemed guilty of~~ an infraction and ~~upon conviction thereof shall be~~  
21 punishable by a fine of ~~not less than \$25 nor more than \$50~~ 100.

22 Section 2. The Planning Department has determined that the actions contemplated in  
23 this Ordinance are in compliance with the California Environmental Quality Act (California  
24 Public Resources Code sections 21000 et seq.). Said determination is on file with the Clerk of  
25 the Board of Supervisors in File No. 051605 and is incorporated herein by reference.


