4 **Francisco against the Philadelphia Indemnity Insurance Company for \$780,000; the**
5 **lawsuit was filed on October 2, 2015, in United States District Court, Case**
6 **No. 15-cv-04557; entitled City and County of San Francisco v. Philadelphia Indemnity**
7 **Insurance Company; the lawsuit involves a dispute over whether the City is covered**
8 **under the terms of a commercial liability insurance policy.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
12 authorizes the City Attorney to settle the action entitled City and County of San Francisco v.
13 Philadelphia Indemnity Insurance Company, United States District Court, Case
14 No. 15-cv-04557 by the payment of \$780,000. The lawsuit involves a dispute over whether
15 the City is covered as an additional insured under a commercial liability insurance policy
16 issued by Philadelphia Indemnity Insurance Company.

17 Section 2. The above-named action was filed in United States District Court on
18 October 2, 2015, and the following parties were named in the lawsuit: plaintiff: City and
19 County of San Francisco; defendant: Philadelphia Indemnity Insurance Company.


