3 Resolution authorizing the Department of Human Services to accept retroactively and expend a
4 grant in the amount of \$500,000 from the Annie E. Casey Foundation for the
5 implementation of the San Francisco Family-to-Family Initiative.

7 WHEREAS, The Department of Human Services desires to develop a network of family
8 foster care that is more neighborhood-based, culturally sensitive and located primarily in the
9 communities in which the children live; to assure that scarce family foster-home resources are
10 provided to all those children who in fact must be removed from their homes; to reduce
11 reliance on institutional or congregate care by meeting the needs of many more of the children
12 currently in those settings through relative or family foster care; and,

13 WHEREAS, The Department of Human Services desires to hire consultants to develop
14 and implement this program; and

15 WHEREAS, The Annie E. Casey Foundation will grant \$500,000 for this program; and,

16 WHEREAS, The Department proposes to maximize use of available grant funds on
17 program expenditures by not including indirect costs in the grant budget; now, therefore, be it

18 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in
19 the grant budget; and be it






