13	Section 1. Chapter 4 of the Administrative Code is hereby amended by adding Section				
14	4.30, to read as follows:

16	SEC. 4.30. NAMING THE PERMANENT SUPPORTIVE HOUSING DEVELOPMENT				
17	LOCATED AT 1321 MISSION STREET FOR MARGOT ANTONETTY.				
18	(a) Findings.				
19	Margot Antonetty devoted her 30-year career as a respected public health leader and advocate,				
20	helping those who have experienced mental illness, HIV, and homelessness. From the late 1980s				
21	through the early 1990s, Antonetty was an AIDS activist and worked at Baker Places, a nonprofit				
22	treatment center that has since merged with PRC. She later began a decades-long career with the City				
23	and County of San Francisco, joining the Department of Public Health (DPH) in 1998 as Director of				
24	Programs, overseeing funding received under the Ryan White HIV/AIDS program.				
25					

1	From 2007 to 2012, Antonetty served as the Deputy Director of Housing and Urban Health, and
2	in that role, she is credited with creating permanent supportive housing as it is known in San
3	Francisco. Antonetty helped to establish the Direct Access to Housing Program (DAH) the City's
4	nationally recognized permanent supportive housing program for people experiencing homelessness

17	(b) The Margot.
18	The permanent supportive housing development located at 1321 Mission Street is named "The
19	Margot," in recognition of Margot Antonetty's invaluable contributions to the City of San Francisco.
20	(c) Signage.
21	By no later than January 1, 2023, the Department of Homelessness and Supportive Housing
22	shall install signage identifying the permanent supportive housing development located at 1321
23	Mission Street as "The Margot." In addition, by that date, the Department of Homelessness and
24	Supportive Housing shall erect a plaque on or inside of the building with a brief description
25	

1	recognizing Margot Antonetty's contributions to the City. The Department shall have discretion to				
2	determine the precise location of the plaque, and its size, design, and content.				
3					
4	Section 2. Effective Date. This ordinance shall become effective 30 days after				
5	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the				
6	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board				
7	of Supervisors overrides the Mayor's veto of the ordinance.

LEGISLATIVE DIGEST

[Administrative Code - Naming the Permanent Supportive Housing Development at 1321 Mission Street for Margot Antonetty]

Ordinance amending the Administrative Code to name the permanent supportive housing development located at 1321 Mission Street in memory of public health advocate Margot Antonetty.

Existing Law

There is no law that regulates the name of the building located at 1321 Mission Street.

Amendments to Current Law

The proposed ordinance would name the permanent supportive housing development located at 1321 Mission Street "the Margot," in memory of public health advocate Margot Antonetty, and would require the Department of Homelessness and Supportive Housing to post signage reflecting the name of the building and noting Margot Antonetty's accomplishments.

Background Information

Margot Antonetty devoted her 30-year career as a respected public health leader and advocate, helping those who have experienced mental illness, HIV, and homelessness. From the late 1980s through the early 1990s, Antonetty was an AIDS activist and worked at Baker Places, a nonprofit treatment center that has since merged with PRC. She later began a decades-long career with the City and County of San Francisco, joining the Department of Public Health (DPH) in 1998 as Director of Programs, overseeing funding received under the Ryan White HIV/AIDS program.






