3 **Resolution supporting the Janitors who have worked at 1 South Van Ness Avenue**  
4 **represented by Local 87 to be reinstated.**

6 WHEREAS, The work that Janitors do is often not seen and underappreciated as an  
7 important part of building maintenance; and

8 WHEREAS, Over the past few years with addition of mandatory recycling and  
9 composting the work that Janitors do citywide has increased with little consideration to  
10 compensation and health and workplace safety; and

11 WHEREAS, Recently the City of San Francisco purchased a building at 1 South Van  
12 Ness that had previously been privately owned; and

13 WHEREAS, Yesterday the City and County of San Francisco awarded the contract for  
14 janitorial services, that for over two decades had been a union contract, to a non-union  
15 contractor that is not obligated to pay similar health and pension benefits to its workers; and

16 WHEREAS, The new company, Aim To Please, has laid off all twelve of the janitors  
17 that work at 1 South Van Ness and will replace them with lower-paid workers who will not  
18 receive the same health and welfare benefits; now, therefore, be it

19 RESOLVED, That the San Francisco Board of Supervisors affirms its support for the  
20 janitors who have worked at 1 South Van Ness represented by Local 87 and will do all in its  
21 power to reinstate those workers.


