15 WHEREAS, The Police Department has filed zero (0) protests with the  
16 Department of Alcoholic Beverage Control under California Business and Professions  
17 Code, Section 24013, and recommends that the Department of Alcoholic Beverage  
18 Control issue the liquor license; now, therefore, be it

19 RESOLVED, That in accordance with California Business and Professions Code,  
20 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
21 hereby determines that the transfer of a Type 21 off-sale general license from 424  
22 Hayes Street to 559 Hayes Street (District 5) to Ramiz Yousef for Nabila's Naturals,  
23 Inc., dba Nabila's Naturals, will serve the public convenience or necessity of the City  
24 and County of San Francisco; and, be it

1           FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
2 San Francisco hereby endorses and adopts the recommendations of the Police  
3 Department, and recommends that the Department of Alcoholic Beverage Control issue  
4 the license with conditions.
