WHEREAS, The Department of Public Health desires to increase the Medicaid and Medicare SSI Ratio Components of the disproportionate share reimbursement received by San Francisco General Hospital; and,

WHEREAS, The revenue collected by said contract will exceed one million dollars (\$1,000,000); and,


WHEREAS, Section 9.118 of the San Francisco Charter requires that such contracts be approved by the Board of Supervisors; now, therefore, be it


