AUTHORIZING THE DISTRICT ATTORNEY TO RETROACTIVELY CONTRACT FOR, ACCEPT AND EXPEND FUNDS IN THE AMOUNT OF \$481,870, AND WAIVE INDIRECT COSTS DUE TO FUNDING CONSTRAINTS, WHICH HAVE BEEN ALLOCATED FROM THE STATE BOARD OF CONTROL VICTIMS OF CRIME PROGRAM, AN AGENT OF THE STATE OF CALIFORNIA, FOR A PROJECT ENTITLED "JOINT POWERS AGREEMENT WITH VICTIM AND WITNESS ASSISTANCE PROGRAM" FOR THE TWELVE MONTH PERIOD July 1, 1998 THROUGH June 30, 1999.

WHEREAS, the District Attorney and the City and County of San Francisco desire to continue a project designated the Joint Powers Agreement between the Victim and Witness Assistance Program and the State Board of Control Victims of Crime Program in accordance with Government Section 13835, for the purpose of verification of victim compensation claims; and,

WHEREAS, the funds received hereunder shall not be used to supplant local funds that would, in the absence of the California Victim Witness Assistance Program, be made available to support the assistance of victims and witnesses of crime , now, therefore, be it,


RESOLVED, that the Board of Supervisors hereby authorizes the District Attorney of the City and County of San Francisco to retroactively contract for, accept and expend funds of \$481,870, waiving indirect costs, for a project entitled "Joint Powers Agreement with Victim and Witness Program" for the twelve-month period July 1, 1998 through June 30, 1999 and to execute




