[Public Education Enrichment Fund – First Five Commission]

Resolution approving the San Francisco First Five Commission expenditure plan for the Public Education Enrichment Fund for Fiscal Year 2008-09.

WHEREAS, Charter Section 16.123-2 establishes the Public Education Enrichment Fund (the "fund") and designates one-third of the fund for universal access to preschool, onethird for sports, library, arts, and music programs and the remaining one-third of the fund, or in-kind services of equal value, for general education purposes; and.

WHEREAS, the total allocation to the fund for FY 2008-09 is \$45.0 million; and,

WHEREAS, the allocation of the funds for universal access to preschool amounts to \$15.0 million and is allocated to the City's First Five Commission; and,

WHEREAS, the Charter allows the City to suspend up to 25% of the allocation in a year where the City's deficit is in excess of \$100 million, and

WHEREAS, the Mayor's FY08-09 budget suspends 25%, or \$3.75 million of the allocation to the First Five Commission for FY 08-09 for a total of \$11.25 million, and

WHEREAS, the First Five Commission has proposed a plan to use the allocation of \$11.25 million for preschool education to increase and improve preschool spaces, program development, facility investments, and professional development of preschool teachers; as prescribed by the Charter; and,

WHEREAS, the First Five Commission's estimated available budget in FY 2008-09 also includes \$2.3 million in carry-forward of unspent funds from prior year allocations, interest earnings and matching funds; and,

WHEREAS, the Controller's Office has reviewed the First Five Commission's expenditure plan, finds it to be consistent with the requirements of the Charter, and has provided comments to the Mayor and the Board of Supervisors; now, therefore, be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco approves the expenditure plan as proposed by the San Francisco First Five Commission for FY 2008-09.
