2 AMENDING CHAPTER 2, ARTICLE I, OF PART I OF THE SAN FRANCISCO MUNICIPAL  
3 CODE (ADMINISTRATIVE CODE), BY ADDING SECTION 2.6-4, TO REQUIRE PERSONS  
4 SEEKING APPOINTMENT BY THE BOARD OF SUPERVISORS TO BOARDS AND  
5 COMMISSION TO DISCLOSE FELONY CONVICTIONS.

7 Note: This entire section is new.

8 Be it ordained by the People of the City and County of San Francisco:

9  
10 Section 1. Chapter 2 of the San Francisco Administrative Code is hereby amended by  
11 adding Section 2.6-4, to read as follows:

12 **SEC. 2.6-4. DISCLOSURE OF FELONY CONVICTIONS.**

13 Any person applying to the Board of Supervisors for appointment to a board,  
14 commission, committee, task force, or other body, shall submit, in addition to any other  
15 information required as part of the application process, a written statement under penalty of  
16 perjury disclosing any felony convictions.

17 These requirements shall not apply to mayoral nominations to boards and commissions  
18 submitted to the Board of Supervisors pursuant to Charter Section 3.100(16).




