

1 [Software License and Maintenance Agreement - Mythics Inc. - Oracle Licenses and Software  
2 Support - Not to Exceed \$11,832,968.89]

3 **Resolution authorizing the General Manager of the San Francisco Public Utilities**  
4 **Commission to execute Agreement No. CS-1090 with Mythics Inc. for the purchase of**  
5 **certain as-needed Oracle licenses and software support, for an amount not to exceed**  
6 **\$11,832,968.89, and with an anticipated term to commence November 30, 2017, through**  
7 **March 22, 2023.**

9 WHEREAS, The San Francisco Public Utilities Commission (SFPUC) utilizes a wide  
10 range of Oracle licenses for its Customer Care and Billing System, as well as various  
11 applications within its Infrastructure division; and

12 WHEREAS, Existing license restrictions limit the SFPUC in its ability to implement new  
13 rate structures, upgrade its systems to latest vendor release of products, troubleshoot system  
14 issues, and provide adequate end-user access to said systems; and

15 WHEREAS, It is necessary to secure a vendor to provide as-needed Oracle licenses  
16 and software support to supplement the SFPUC's operations; and

17 WHEREAS, On June 13, 2017, the SFPUC, through the Office of Contract  
18 Administration, advertised a Request for Proposals (WP17001780) for the purchase of certain  
19 as-needed Oracle licenses and software support; and

20 WHEREAS, The SFPUC and Office of Contract Administration evaluation of the  
21 proposals received in response to WP17001780 resulted in the determination that Mythics  
22 Inc. ("Mythics") was the lowest responsive bidder; and

23 WHEREAS, The SFPUC now wishes to enter into Agreement No. CS-1090  
24 ("Agreement") with Mythics for the purpose of procuring as-needed Oracle licenses and  
25 software support, in accordance with Mythics' proposal in response to WP17001780; and

1           WHEREAS, The cost of the Agreement will not exceed \$11,832,968.89 and will be  
2 funded by SFPUC Information Technology (IT) Services and SFPUC Infrastructure budgets  
3 based on actual usage and orders placed against the Agreement; and

4           WHEREAS, The Agreement is anticipated to begin on November 30, 2017, and end on  
5 March 22, 2023, and the duration of this agreement is up to five years, three months, and  
6 twenty-three days; and

7           WHEREAS, Pursuant to Charter, Section 9.118, all non-construction contracts entered  
8 into by a department requiring anticipated expenditures of \$10,000,000 or more shall be  
9 subject to approval of the Board of Supervisors by Resolution; and

10          WHEREAS, Mythics is in compliance with the Equal Benefits Provisions of  
11 Administrative Code, Chapter 12B; and

12          WHEREAS, On August 8, 2017, the SFPUC approved Resolution No. 17-0179  
13 authorizing the General Manager of the SFPUC to execute an agreement with Mythics Inc. for  
14 as-needed Oracle licenses and software support for an amount not-to-exceed  
15 \$11,832,968.89, and with a duration of up to five (5) years, three (3) months, and twenty-three  
16 (23) days pending approval by the San Francisco Board of Supervisors pursuant to Charter,  
17 Section 9.118; now, therefore, be it

18          RESOLVED, That the Board of Supervisors authorizes the General Manager of the  
19 SFPUC to enter into an agreement with Mythics Inc. in substantially the form of agreement on  
20 file with the Clerk of the Board of Supervisors in File No. 170669 in an amount not to exceed  
21 \$11,832,968.89 and a term not to exceed five (5) years, three (3) months and twenty-three  
22 (23) days commencing in 2017 and concluding in 2023; and, be it

23          FURTHER RESOLVED, That within (30) days of the execution of the Agreement CS-  
24 1090 the General Manager of the San Francisco Public Utilities Commission shall provide the  
25 signed contract to the Clerk of the Board for inclusion in the official file.
