Dear Supervisors:

I am a Bernal Heights resident and a partner at the law firm of Covington & Burling LLP in San Francisco, and I write in support of Bobbie J. Wilson's nomination to the Board of Appeals. I have known Bobbie for 16 years as a law firm associate, law firm partner, neighbor, and friend. Based on my long-standing professional and personal relationship with Bobbie, I can think of no person better situated to serve San Francisco as a Commissioner on the Board of Appeals.

Bobbie is an outstanding and highly respected attorney. This dedication to her clients and the judicial system has led to Bobbie's well-deserved placement on a broad array of "best of" lists, including the Daily Journal's Top 100 Leading Women Lawyers, Daily Journal's Top 75 Women Lawyers, The Recorder's Women Leaders in Law, and Law & Politic's Northern California "Super Lawyers." The private sector's acknowledgement of Bobbie's legal prowess has been matched by the federal judiciary, which appointed her to be a Lawyer Representative for the Northern District of California, as well as her law partners who have selected her for leadership and management positions. As I can personally attest, Bobbie's intellectual brilliance is on par with her ability to cut quickly through the noise to focus on the core issues that matter and to make practical decisions.

Bobbie has knocked down barriers. In 2010, Bobbie became the first African American woman partner in the 98 year history of her law firm, Perkins Coie. Bobbie is committed to fairness and ensuring equal access to justice. Refusing to be satisfied with her individual success, Bobbie, upon graduating from Columbia University Law School, moved to San Francisco to serve as the Felix Velarde-Munoz Fellow at the Legal Aid Society-Employment Center. Throughout her law firm career, Bobbie has been tireless in leveraging and brokering millions of dollars in private sector resources to bring cases that have been both national in scope and personal in nature. Among Bobbie's highest profile cases have been her service as lead pro bono counsel in representing the City of San Francisco, the Mayor, and the Assessor-Recorder in the figh' extend marriage rights to gays and $\mathfrak{l}\epsilon$ ans. Bobbie went on to play a lead role in securing the City's ultimate victory in front of the California Supreme Court, and I was honored to attend her own wedding following this legal victory. Bobbie has also handled countless numbers of less visible but equally significant representations on behalf of individual farm workers, low income workers, black firefighters, and many others. Bobbie's efforts have not rested with the provision of legal services. On the community and advocacy front, Bobbie served on the board of the San Francisco-based National Center for Lesbian Rights (NCLR) for six years as well as many other community associations.

Bobbie's list of achievements is rivaled only by her personal integrity, commitment to fair play, and infectious personality. When I was an associate, Bobbie was one of the few partners I and other associates trusted with our professional development. She was a tough grader with exacting standards, but we never questioned Bobbie's fairness and commitment to us as lawyers and as people. Emails sent by departing associates regularly singled Bobbie out for her mentorship and support. When I was elected to the partnership, my trust and confidence in Bobbie only strengthened as I observed her unwavering commitment to direct talk, her ability as a management committee member to develop consensus among the partners or at a minimum guide the partnership into making decisions, the ease with which she navigated firm politics for the betterment of the group, her unerring judgment, and, above all, Bobbie's work ethic.

Bobbie's commitment to San Francisco is as unwavering as her love for her wife. And I have no doubt that Bobbie will quickly and deservedly earn the trust and respect of her fellow Board of Appeal Commissioners and the San Francisco residents who appear in front of her.

I'm a long-time professional colleague of Bobbie Wilson and recommend her for appointment to the San Francisco Board of Appeals. Bobbie is a remarkable person, well-qualified for this position, and a pleasure to know and to work with.

I'm a civil appellate litigator here in San Francisco and have known Bobbie for more than 15 years. Board Qualifications:

The Board of Appeals consists of five (5) members, two (2) nominated by the President of the Board of Supervisors, and three (3) members nominated by the Mayor. Each nomination of the Mayor and the President of the Board of Supervisors is subject to approval by the Board of Supervisors. If the Board fails to act on the nomination within 60 days from the date the nomination is transmitted to the Clerk of the Board of Supervisors, the nominee shall be deemed approved.

In order to stagger the terms, the Clerk of the Board of Supervisors shall determine by lot which two (2) of the three (3) Mayoral appointees shall serve an initial two-year term, and which one of the two (2) appointees of the President of the Board of Supervisors shall serve an initial-two year term. The remaining appointees shall serve four-year terms. All subsequent terms shall be four years.

The appointees of both the Mayor and the President of the Board of Supervisors shall take office at 12:00 noon on the first day of July 2002.

The Board of Appeals, a quasi-judicial panel, decides appeals of permits, variances, zoning determinations and other department actions at public hearings.
