WHEREAS, In order to improve access to services for foster care and other Medi-Cal eligible children and youth who are placed outside of San Francisco County, the San Francisco Department of Public Health has developed a contract with the County Mental Health Directors Association to gain access to a statewide provider network managed by an Administrative Services Organization and monitored by the California Mental Health Directors Association; and,

WHEREAS, In order to implement the contract, the City must authorize the State Department of Mental Health to transfer to the County Mental Health Directors Association \$48,330 from the state general funds designated for distribution to San Francisco to provide Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) services in FY 2000-2001; and,

WHEREAS, These monies will be matched by Medi-Cal Federal Financial Participation of \$51,670 for total funding of \$100,000; and,

WHEREAS, These monies will fund provider certification, contracting, services and claims payment, authorized on behalf of San Francisco County Medi-Cal beneficiaries by an Administrative Services Organization monitored by the California Mental Health Directors Association through their contract with the California Mental Health Directors
