

1 [Transfer state funds to CMHDA for contract services to improve access to mental health
2 treatment for children in foster care and other children placed outside of San Francisco.]

3 **Resolution endorsing the transfer of state general funds from the state to the**
4 **California Mental Health Directors Association for a contract to provide services to**
5 **foster care and other Medi-Cal eligible children placed outside of San Francisco.**

7 WHEREAS, In order to improve access to services for foster care and other Medi-
8 Cal eligible children and youth who are placed outside of San Francisco County, the San
9 Francisco Department of Public Health has developed a contract with the County Mental
10 Health Directors Association to gain access to a statewide provider network managed by
11 an Administrative Services Organization and monitored by the California Mental Health
12 Directors Association; and,

13 WHEREAS, In order to implement the contract, the City must authorize the State
14 Department of Mental Health to transfer to the County Mental Health Directors Association
15 \$48,330 from the state general funds designated for distribution to San Francisco to
16 provide Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) services in FY
17 2000-2001; and,

18 WHEREAS, These monies will be matched by Medi-Cal Federal Financial
19 Participation of \$51,670 for total funding of \$100,000; and,

20 WHEREAS, These monies will fund provider certification, contracting, services and
21 claims payment, authorized on behalf of San Francisco County Medi-Cal beneficiaries by
22 an Administrative Services Organization monitored by the California Mental Health
23 Directors Association through their contract with the California Mental Health Directors

Association, to improve access to mental health treatment for foster care and other San Francisco MediCal beneficiaries placed outside of San Francisco county; now, therefore, be it

RESOLVED, That the Board of Supervisors adopt this resolution authorizing the State Department of Mental Health to transfer to the County Mental Health Directors Association \$48,330 from the state general funds designated for distribution to San Francisco to provide Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) services in FY 2000-2001; and, be it




