3 **Ordinance authorizing a specific unit of Parking Control Officers to issue citations for**
4 **violation of California Vehicle Code Section 22400 regarding bringing a vehicle to a**
5 **complete stop so as to impede traffic, and omitting reference to California Vehicle**
6 **Code Section 41102 which has been repealed.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. The San Francisco Traffic Code is hereby amended by amending Section
12 12, to read as follows:

13 **SEC. 12. POLICE COMMISSION REGULATION OF TRAFFIC; CIVILIAN EMPLOYEES**
14 **AUTHORIZED TO ENFORCE PARKING REGULATIONS; DEPARTMENT OF PUBLIC**
15 **WORKS CONTROL OF TRAFFIC-CONTROL DEVICES.** The Police Commission is hereby
16 authorized to direct, control, divert and regulate all traffic by means of Police Officers or
17 persons designated as special Police Officers limited to the control and direction of traffic by
18 the Chief of Police pursuant to Section 35.9 of the Charter for the exclusive or main purpose
19 of enforcing the provisions of Division 11 of the Vehicle Code of the State of California, and
20 the emergency use of temporary signs and devices; provided, however, that any regularly
21 employed and salaried civilian employee of the Department of Parking and Traffic designated
22 by the Director of Parking and Traffic to enforce parking regulations (hereinafter referred to as
23 a "Parking Control Officer") shall have the power and authority to issue parking control notices
24 as provided by ~~Section 41102 and~~ 40202 of the Vehicle Code of the State of California. In
25 addition, any Parking Control Officer assigned to the "Robert Greenstrand Disable Placard

1 Detail” shall have the power and authority to issue misdemeanor citations for violations of
2 California Vehicle Code Section 4461 and further authorizes certain designated Parking Control
3 Officers to have the power and authority to issue citations for violations of Vehicle Code Section
4 22400.

5 The Department of Parking and Traffic is hereby authorized to design, place,
6 operate and maintain, or cause to be placed, operated and maintained, street traffic-control
7 devices and signs, with respect to streets and highways within its jurisdiction, as may be
8 necessary to indicate and carry out the provisions of this Code or the Vehicle Code of the
9 State of California, or to direct or warn traffic upon said streets or highways.
