2 AUTHORIZING THE MAYOR'S OFFICE OF ECONOMIC DEVELOPMENT TO ACCEPT AND
3 EXPEND A GRANT IN THE AMOUNT OF \$37,000 FROM THE CALIFORNIA TRADE AND
4 COMMERCE AGENCY TO FUND RESEARCH ANALYZING THE LOCAL ECONOMY AND THE
5 SKILLS NEEDED IN TODAY'S LABOR FORCE, WAIVING INDIRECT COSTS.

6 WHEREAS, The Mayor's Office of Economic Development works
7 closely with city agencies and local businesses to support local
8 workforce development initiatives; and,

9 WHEREAS, on August 14, 1998, The Trade and Commerce Agency
10 executed a grant agreement with the City and County of San Francisco
11 for the Job Creation Investment Fund (JCIF); and,

12 WHEREAS, the grant agreement period is from August 14, 1998 to
13 September 30, 1999 and authorizes \$37,000 in funds to be allocated
14 toward job creation efforts; and,

15 WHEREAS, indirect costs are not eligible for reimbursement under
16 the terms of the grant agreement; now, therefore, be it

17 RESOLVED, That City and County of San Francisco hereby
18 authorizes the Director of the Mayor's Office of Economic Development
19 to accept and expend \$37,000 from the California Trade and Commerce
20 Agency in support of the City's job creation and economic development
21 efforts, waiving indirect costs.




