7 WHEREAS, The 2014-2015 San Francisco Civil Grand Jury published a report, entitled  
8 "CleanPowerSF At Long Last" (Report) on July 16, 2015; and

9 WHEREAS, The Board of Supervisors' Government Audit and Oversight Committee  
10 (GAO) conducted a public hearing to hear and respond to the Report on October 1, 2015; and

11 WHEREAS, the Board of Supervisors adopted Resolution No. 384-15 reflecting the  
12 GAO responses to the Report on October 6, 2015, a copy of which is on file with the Clerk of  
13 the Board of Supervisors in File No. 150605; and

14 WHEREAS, Recommendation No. 4 states: "That San Francisco Public Utilities  
15 Commission (SFPUC) integrate the GoSolarSF program into CleanPowerSF to take  
16 advantage of their complementary relationship"; and

17 WHEREAS, The Board of Supervisors on October 6, 2015, responded in Resolution  
18 No. 384-15 that Recommendation No. 4 "will be implemented for reasons as follows: As the  
19 SFPUC's response indicates, CleanPowerSF is designed so that "its customers will be able to  
20 access GoSolarSF incentives. [But] the amount of funding CleanPowerSF will contribute to  
21 GoSolarSF has not yet been determined." The Board of Supervisors enthusiastically supports  
22 this integration and though it cannot predict exactly when the effort will be completed, the  
23 Board anticipates it to be one year after the CleanPowerSF rollout in the Spring of 2016, or by  
24 May 2017"; and

1           WHEREAS, the GAO conducted an additional hearing on January 14, 2016, to receive  
2 an update from City departments on Recommendation No. 4; now, therefore, be it

3           MOVED, That Recommendation No. 4 will not be implemented for reasons as follows:  
4 Though the Board of Supervisors enthusiastically supports this effort, and though the relevant  
5 department, the San Francisco Public Utilities Commission, is actively working to implement it,  
6 the restrictive response options imposed by the Civil Grand Jury process prevent the Board  
7 from offering an accurate response. The recommendation involves a multi-year effort being  
8 conducted outside of the Board's direct authority, and there is no response option for that  
9 situation; and, be it

10           FURTHER MOVED, That the Board of Supervisors urges the Mayor to cause the  
11 implementation of accepted recommendation through his/her department heads and through  
12 the development of the annual budget.

8 WHEREAS, The 2014-2015 San Francisco Civil Grand Jury published a report, entitled  
9 "San Francisco's City Construction Program: It Needs Work" (Report) on July 16, 2015; and

10 WHEREAS, The Board of Supervisors' (BOS) Government Audit and Oversight  
11 Committee (GAO) conducted a public hearing to hear and respond to the Report on October  
12 1, 2015; and,

13 WHEREAS, The Board of Supervisors adopted Resolution No. 385-15 reflecting the  
14 GAO responses to the Report on October 6, 2015, a copy of which is on file with the Clerk of  
15 the Board of Supervisors in File No. 150607; and

16 WHEREAS, Recommendation No. 6 states: "The BOS should request the Budget and  
17 Legislative Analyst (BLA) or City Services Auditor (CSA) to benchmark the City's design and  
18 engineering workforce organizational structure against comparable cities and issue a report";  
19 and

20 WHEREAS, The Board of Supervisors on October 6, 2015, responded in Resolution  
21 No. 385-15 that Recommendation No. 6 "requires further analysis for reasons as follows: A  
22 benchmarking analysis could provide important and helpful insight into best practices for how  
23 to improve the organizational structure of the City's design and engineering workforce, and  
24 merits further consideration. The Board of Supervisors will confer with their independent  
25

1 Budget and Legislative Analyst's office to assess how to best address this recommendation  
2 by January 2016"; and

3 WHEREAS, The Board of Supervisors on October 6, 2015, responded in Resolution  
4 385-15 that Recommendation No. 8 "requires further analysis for reasons as follows: This  
5 recommendation overlaps with recent and existing work of a workgroup of Chapter 6  
6 departments. Legislation modernizing Chapter 6 went into effect August 1, 2015, after more  
7 than a year of collaboration. The next round of changes, including a shared database to track  
8 contractor performance, is being discussed now with a goal of implementation by Summer  
9 2016. The Board of Supervisors will confer with their independent Budget and Legislative  
10 Analyst's office to assess how to best address this recommendation by January 2016"; and

11 WHEREAS, The Board of Supervisors on October 6, 2015, responded in Resolution  
12 385-15 that Recommendation No. 9 "requires further analysis for reasons as follows: This  
13 recommendation will be revisited by the Board of Supervisors by January 2016 as part of the  
14 ones being considered when further amendments to Chapter 6 of the Administrative Code are  
15 brought forward"; and

16 WHEREAS, the GAO conducted an additional hearing on January 14, 2016, to receive  
17 an update from City departments on Recommendation Nos. 6, 8 and 9; now, therefore, be it



14 WHEREAS, The Board of Supervisors adopted Resolution No. 388-15 reflecting the  
15 GAO responses to the Report on October 20, 2015; a copy of which is on file with the Clerk of  
16 the Board of Supervisors in File No. 150609; and

17 WHEREAS, Recommendation No. 3 states: "A user satisfaction survey should be sent  
18 to all Department of Technology (DT) clients, before the end of 2015 and later in six months  
19 after the reorganization, to assess whether the new accountability structure is making a  
20 difference for clients"; and
