15 Be it ordained by the People of the City and County of San Francisco:

16 Section 1. The Board of Supervisors hereby adopts and implements the Second  
17 Amendment to the 2022-2024 Memorandum of Understanding (“MOU”) between the City and  
18 County of San Francisco and the Municipal Executives Association, effective July 1, 2023, to  
19 adopt a side letter agreement to reinstate the Airport Employee Transit Pilot Program at San  
20 Francisco International Airport.

21 The Second Amendment to the MOU so implemented is on file with the Clerk of the  
22 Board of Supervisors in Board File No. 230568.

23 Section 2. The Board of Supervisors hereby authorizes the Department of Human  
24 Resources to make non-substantive ministerial or administrative corrections to the MOU.

1 Section 3. This ordinance shall become effective upon enactment. Enactment occurs  
2 when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not  
3 sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the  
4 Mayor's veto of the ordinance.


