3 Ordinance amending the Health Code to comprehensively revise the regulation of

4 massage practitioners, massage establishments, massage outcall services, and sole

5 practitioner massage establishments by, among other things: 1) authorizing the

6 Director of Health ("Director") to access local, state, and federal criminal history

7 information of permit applicants and permit holders; 2) eliminating temporary massage

8 practitioner permits; 3) clarifying the administrative process by which permit

9 applicants and permit holders may appeal a decision to deny, suspend, or revoke a

10 permit; 4) ~~authorizing the Director to deny a massage establishment permit to an~~

11 ~~applicant who has been convicted of any offense related to prostitution or solicitation~~

12 ~~of prostitution, unless the conviction was vacated based on a showing that the~~

13 ~~individual was a victim of human trafficking; 54) adding or revising massage~~

14 ~~establishment operating standards relating to vermin, employee areas, locked doors,~~

15 ~~residential use, and advertising; 65) prohibiting a massage business from operating a~~

8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. The Health Code is hereby amended by revising Sections 29.4, 29.5, 29.10,
10 29.11, 29.12, 29.17, 29.18, 29.25, 29.26, 29.27, 29.29, 29.31, 29.32, 29.33, 29.41, 29.42, and
11 29.45, deleting Sections 29.3, 29.13, 29.14, and existing Section 29.46, and adding new
12 Sections 29.6, 29.43, and 29.46, to read as follows:

13 ~~**SEC. 29.3. COMPLAINT LINE.**~~

14 ~~*The Director shall maintain a phone line for inquiries and complaints regarding massage*~~
15 ~~*businesses and practitioners*~~

16 **SEC. 29.4. TRANSFER OF PERMIT; SALE OF MASSAGE BUSINESS.**

17 (a) No permit issued under this Article 29 shall be transferable under any
18 circumstances, including but not limited to the sale of the ~~m~~Massage ~~b~~Business.

19 (b) Upon the effective date of the sale of a Massage Business, the permit for the Massage
20 Business shall expire by operation of law. If a permittee sells a Massage Business, the permittee shall
21 promptly surrender the permit to the Director no later than the effective date of the sale. This
22 obligation is not dependent on the Director's requesting the surrender, but arises by operation of law
23 as a result of the sale of the Massage Business. If the permittee fails to surrender the permit to the
24 Director as required by this subsection (b), the Director may, after giving the permittee notice by mail
25

1 or electronically of the proposed action and an opportunity to respond, establish that the permit has
2 expired by operation of law and hence is not a valid permit, and that it must be surrendered.

3
4 **SEC. 29.5. DEFINITIONS.**

5 For the purposes of this Article 29:

6 "Approved School" or "Approved Massage School" means a school that provides
7 instruction and training in massage and meets the requirements of California Business and
8 Professions Code Section 4601(a).

9 "CAMTC" means the California Massage Therapy Council as established in California
10 Business and Professions Code Section 4602, or any successor agency.

11 "CAMTC Certified Practitioner" means an individual who administers massage for
12 compensation and holds a valid and active certificate to practice massage issued by CAMTC
13 pursuant to California Business and Professions Code Sections 4604 or 4604.2.

14 "City" means the City and County of San Francisco.

15 "Compensation" means a payment, loan, advance, donation, contribution, deposit,
16 forgiveness of debt, or gift of money or anything of value.

17 "Convicted" means having pled guilty or having received a verdict of guilty, including a
18 verdict following a plea of nolo contendere, to a crime.

19 "Department" means Department of Public Health.

20 "Director" means the Director of the Department of Public Health or any individual
21 designated by the Director to act on his or her behalf.

22 "Inspector" means a Department employee responsible for conducting inspections on behalf of
23 the Department.

1 "Massage" means any method of pressure on or friction against, or stroking, kneading,
2 rubbing, tapping, pounding, vibrating, or stimulating the external soft pads of the body with the
3 hands or with the aid of any apparatus or appliance.

4 "Massage Business" means Massage Establishment, Out-call Massage Service, and
5 Sole Practitioner Massage Establishment, collectively.

6 "Massage Establishment" means a fixed place of business where more than one
7 individual administers Massage for Compensation, excluding those locations where Massage
8 is provided only on an outcall basis.

9 "Massage Practitioner" means any individual who administers Massage for
10 Compensation pursuant to a permit issued by the Director under this Article 29.

11 *Notwithstanding the previous sentence, "Massage Practitioner" does not include CAMTC Certified*
12 *Practitioner.*

13 "Outcall Massage Service" means any business other than a Massage Establishment
14 or Sole Practitioner Massage Establishment that provides Massage for Compensation at a
15 location designated by the client rather than on its premises.

16 "Owner" means any individual, partnership, firm, association, corporation, or
17 combination of individuals of whatever form or character with an ownership interest in a
18 business that provides Massage services.

19 "Sole Practitioner" means a Massage Practitioner permit holder or CAMTC Certified
20 Practitioner who provides Massage for Compensation without any partners, associates, or
21 employees, and absent any business relationship with a Massage Establishment.

22 "Sole Practitioner Massage Establishment" means a fixed place of business solely
23 owned by a Massage Practitioner permit holder or CAMTC Certified Practitioner, which
24 individual is the only person who provides Massage for Compensation. The business location
25

1 may be shared by up to two to four Massage Practitioners or CAMTC Certified Practitioners in
2 any combination, except as otherwise provided pursuant to Section 29.29(e).

3
4 **SEC. 29.6. ACCESS TO SUMMARY CRIMINAL HISTORY INFORMATION.**

5 The Director is authorized to access local, state, and federal level summary criminal history
6 information for licensing, permitting, and/or certification of Massage Businesses and Massage
7 Practitioners, and for the suspension or revocation of licenses, permits, and/or certification of Massage
8 Businesses and Massage Practitioners, and may not disseminate the information to a private entity.

9
10 **SEC. 29.10. PERMIT REQUIRED FOR MASSAGE PRACTITIONER; EXEMPTIONS.**

11 (a) **Permit Required.** It shall be unlawful for any individual to administer Massage for
12 Compensation without first obtaining a Massage Practitioner permit from the Director, unless
13 that individual is exempt from the permit requirement under subsection (b).

14 (b) **Exemptions.** The following massage service providers are exempt from the permit
15 requirement in subsection (a):

16 (1) CAMTC Certified Practitioners. A CAMTC Certified Practitioner shall be
17 ineligible for a Massage Practitioner Permit so long as he or she holds a CAMTC certification.

18 (2) Physicians, surgeons, chiropractors, osteopaths, nurses, or any physical
19 therapists, who are duly licensed to practice their respective professions in the State of
20 California and persons working directly under the supervision of or at the direction of such
21 licensed persons, working at the same location as the licensed person, and administering
22 massage services subject to review or oversight by the licensed person.

23 (3) Barbers and cosmetologists who are duly licensed under the laws of the
24 State of California, while engaging in practices within the scope of their licenses, and limited
25 to the massaging of the neck, face, scalp, hands, or feet of the clients.

1 (4) Employees of hospitals, nursing homes, mental health facilities, or any
2 other health facilities duly licensed by the State of California, while acting within the scope of
3 their employment.

4 (c) Notwithstanding any provision in this Article 29, starting January 1, 2019, a person may
5 not file and the Department may not accept an application for a Massage Practitioner Permit.

6 (1) The Department shall process and may grant in accordance with this Article 29 any
7 applications for Massage Practitioner Permits filed before January 1, 2019, even if some or all of the
8 processing occurs on or after January 1, 2019.

9 (2) This subsection (c) shall not affect the status of Massage Practitioner Permits issued
10 before January 1, 2019, or those issued under subsection (c)(1) on or after January 1, 2019.

11
12 **SEC. 29.11. APPLICATION FOR MASSAGE PRACTITIONER PERMIT.**

13 (a) **Permit Application.** Every applicant for a Massage Practitioner permit shall:

- 14 (1) File an application with the Director upon a form provided by the Director;
15 (2) Provide a complete set of fingerprints in the manner required by the
16 Director for the purpose of undergoing a criminal background check; and
17 (3) Pay a non-refundable application fee as set forth in Section 29.40.

18 (b) **Applicant Information.** The application form shall require the applicant to provide,
19 under penalty of perjury, the following information:

- 20 (1) The applicant's ~~Age~~ name and residence address;
21 (2) A unique identifying number from at least one government-issued form of
22 identification, such as a social security card, a state driver's license or identification card, or a
23 passport;
24 (3) Written evidence that the applicant is at least 18 years of age;
25 (4) The applicant's height, weight, and color of hair and eyes;

1 (5) The applicant's work history for the five years immediately prior to the date
2 of application; *and*

3 (6) All permits, certificates, or licenses related to the practice of Massage
4 currently or formerly held by the applicant in San Francisco or elsewhere, including any
5 discipline imposed by the issuing authority and a statement whether the applicant is currently
6 the subject of a disciplinary process; *and*

7 (7) All felony or misdemeanor convictions; and

8 (8) Any additional information as required by the Director.

9 (c) **Minimum Educational Requirements.** An applicant for a Massage Practitioner
10 permit shall provide, in a form acceptable to the Director, documentation showing that the
11 applicant has completed not less than 500 hours of instruction in Massage and related
12 subjects at an Approved Massage School.

13 (d) **Proficiency Test.** The Director shall administer a test to all applicants, in each
14 applicant's own language, to confirm basic proficiency in Massage before issuing a permit.

15 (e) **Deadline for submission of supporting documentation.** After reviewing an applicant's
16 application, the Director shall notify the applicant in writing if the application is incomplete. If the
17 Director deems the application to be incomplete, the applicant shall supply the information or
18 documentation that is required for the application to be deemed complete. The applicant shall have 60
19 days from the date that the Director provides notification that the application is incomplete to provide
20 all required information and/or documentation. If the applicant does not provide such information
21 within 60 days, the application will be deemed abandoned and will not receive further consideration.

22
23 **SEC. 29.12. ISSUANCE OF MASSAGE PRACTITIONER PERMIT.**

24 (a) **Time for Decision.** Within ~~60~~90 business days following receipt of a completed
25 application for a Massage Practitioner permit, the Director shall either issue the permit or mail

1 a written statement of his or her reasons for denial thereof to the applicant. If the Director
2 takes neither action, the permit shall be deemed issued.

3 ~~(b) *Hearing on Application.* The Director may, in his or her discretion, hold a hearing on any~~
4 ~~pending application for a Massage Practitioner permit. The Director shall give the applicant at least~~
5 ~~10 days' written notice of the time and place of the hearing.~~

6 ~~(eb)~~ **Grounds for Denial.** No Massage Practitioner permit shall be issued if the
7 Director finds:

8 (1) The applicant is exempt from the permit requirement pursuant to Section
9 29.10; or

10 (2) The applicant has provided materially false information, documents, or
11 testimony in support of the application or in any other matter before the Director; or

12 (3) Within five years immediately prior to the date of application, the applicant
13 has had any license, certificate, or permit related to the practice of Massage revoked or, if
14 from another jurisdiction, suspended under circumstances that qualify for revocation under
15 this Article 29, or is currently the subject of an unresolved disciplinary process that may result
16 in suspension or revocation; or

17 (4) The applicant has been Convicted of any of the following offenses:

18 (A) Any felony involving the use of coercion, force, or violence upon
19 another person; or

20 (B) Any misdemeanor sexual battery; or

21 (C) Any offense involving sexual misconduct with children; or,
22 ~~prostitution, or solicitation of an act of prostitution, unless the conviction was vacated based~~
23 ~~on a showing that the individual was arrested for or convicted of the offense while he or she~~
24 ~~was a victim of human trafficking; or~~

1 (D) Any offense requiring registration pursuant to Section 290 of the
2 California Penal Code or, for Convictions outside California, any offense requiring registration
3 in California under Penal Code Section 290.005; or

4 (5) The applicant has failed to satisfy the education requirements or pass the
5 Massage proficiency test; or

6 (6) The Director concludes that there is good cause to deny the permit in
7 accordance with Section 26 of Article 1 of the Business and Tax Regulations Code; or

8 (7) The applicant has not fully complied with the provisions of this Article 29; or

9 (8) The applicant has not demonstrated eligibility for a permit under this Article 29.

10 (dc) **Discretionary Exception for Criminal Convictions.** The Director may issue a
11 Massage Practitioner permit to any individual Convicted of one of the offenses listed in
12 subsection (eb)(4) of this Section if the Director finds that the offense was not violent, the
13 conviction occurred at least five years prior to the date of application, and the applicant has
14 not been Convicted subsequently of a listed offense.

15 (ed) **Right to Director's Hearing.** If an application for a Massage Practitioner permit
16 is denied, ~~and provided that the Director did not hold a hearing on the application as provided in~~
17 ~~subsection (b) of this Section 29.12,~~ the applicant may appeal the denial within 3015 days of
18 ~~receipt of the date listed on~~ the notice of denial by notifying the Director in writing and explaining
19 in detail the ground or grounds for the appeal. The Director shall conduct a hearing to
20 consider the appeal within 360 days of receiving the notice of appeal and shall notify the
21 applicant of the time and place of the hearing at least 10 days in advance of the hearing. The
22 Director shall oversee the hearing, provide the applicant an opportunity to speak at the
23 hearing, and issue a ruling within 360 days of the conclusion of the hearing. The Director's
24 ruling shall be the final decision of the Department. If the Director does not rule within 360
25 days of the conclusion of the hearing, the permit denial shall be deemed sustained.

1
2 **~~SEC. 29.13. TEMPORARY MASSAGE PRACTITIONER PERMIT.~~**

3 ~~A practitioner of Massage who holds a valid permit, license, or certificate to practice Massage~~
4 ~~issued by another jurisdiction and who has been practicing Massage in that jurisdiction may request a~~
5 ~~temporary Massage Practitioner permit upon completion and submission of an application for a~~
6 ~~Massage Practitioner permit, and payment of all fees for the permit. If requested, the Director shall~~
7 ~~issue the temporary Massage Practitioner permit, which shall be valid for the period during which the~~
8 ~~application is under review, but in no event for more than 60 business days. The Director may revoke~~
9 ~~the temporary permit at any time if he or she finds that the applicant has failed to meet any of the~~
10 ~~requirements of Section 29.12 or violated any provision of this Article 29 or any rules or regulations~~
11 ~~promulgated by the Director related to the practice of Massage.~~

12
13 **~~SEC. 29.14. EDUCATIONAL MATERIALS.~~**

14 ~~The Director shall provide all persons receiving a Massage Practitioner permit with culturally~~
15 ~~and linguistically appropriate educational materials regarding the City and County of San Francisco~~
16 ~~Sanctuary policy, employee rights, and information on a variety of resources, including linkages to~~
17 ~~health services, victim assistance services, and emergency numbers and hotlines to call for information~~
18 ~~and assistance.~~

19
20 **SEC. 29.17. MASSAGE PRACTITIONER CONDUCT REQUIREMENTS.**

21 (a) **Required Attire.** Massage Practitioners shall remain fully clothed while
22 administering massage or otherwise present in a part of the Massage Establishment to which the
23 public has access (e.g., massage rooms, reception areas, publicly accessible restrooms)~~visible to clients~~
24 ~~on business premises~~, including premises designated by the client through an Outcall Massage
25 Service. The Massage Practitioner's attire shall not include: (1) attire that is transparent, see-

1 through, or that substantially exposes the Practitioner's undergarments; (2) swim attire, unless
2 the Practitioner is providing a water-based massage modality that has been approved by
3 CAMTC; or (3) attire that exposes the individual's breasts, buttocks, or genitals.

4 (b) **Lewd Conduct Prohibited.** Massage Practitioners shall not engage in lewd
5 conduct on business premises, including locations designated by the client through an Outcall
6 Massage Service. Lewd acts include, but are not limited to: the performance of acts or
7 simulated acts of sexual intercourse, masturbation, ~~sodomy~~, bestiality, copulation (oral, anal or
8 vaginal), or flagellation; the actual or simulated caressing or fondling by one adult human
9 being of the anus or genitals of another adult human being; the actual or simulated displaying
10 of the pubic hair, anus, vagina, penis, vulva, buttocks, areola, or any other external genitalia of
11 the human body.

12
13 **SEC. 29.18. SUSPENSION OR REVOCATION OF MASSAGE PRACTITIONER**
14 **PERMIT.**

15 (a) **Grounds for Suspension or Revocation.** The Director may revoke or suspend
16 any Massage Practitioner permit ~~after a hearing~~ if the Director finds:

17 (1) Facts sufficient to support denial of a Massage Practitioner permit on any
18 ground set forth in Section 29.12; or

19 (2) The Massage Practitioner has violated the conduct requirements in Section
20 29.17; or

21 (3) The Director finds that there is good cause to suspend or revoke the permit
22 in accordance with Sections 24 or 26 of Article 1 of the Business and Tax Regulations Code; or

23 (4) The Massage Practitioner has violated any of the provisions of this Article
24 29 or a rule or regulation adopted by the Director related to the practice of Massage; or

1 (5) The Massage Practitioner has not paid the Massage Practitioner Fee as required by
2 Section 29.40 of this Article 11, and 30 days have elapsed since notice of delinquency.

3 ~~(b) Hearing. A Massage Practitioner who has been cited by the Department for a violation of~~
4 ~~any provision of this Article 29 shall be scheduled to appear at hearing before the Director. The~~
5 ~~Director shall provide the Massage Practitioner at least 10 days' written notice of the time, place, and~~
6 ~~grounds for the hearing. If requested by the Massage Practitioner, the Director shall make available all~~
7 ~~documentary evidence against him or her within five days of the request. If the Director does not~~
8 ~~provide the requested documentary evidence within five days, the Massage Practitioner may request,~~
9 ~~and the Director shall grant, a continuance of the hearing date. At the hearing, the Massage~~
10 ~~Practitioner shall be provided an opportunity to refute all evidence against him or her. The Director~~
11 ~~shall oversee the hearing and issue a ruling within 30 days of the conclusion of the hearing. If the~~
12 ~~Director fails to issue a ruling within this time period, the permit shall not be suspended or revoked.~~
13 ~~The Director's ruling shall be the final decision of the Department.~~

14 ~~(c) Summary Suspension. The Director may suspend summarily any Massage Practitioner~~
15 ~~permit issued under this Article 29 pending a noticed suspension or revocation hearing when, in the~~
16 ~~opinion of the Director, the public health or safety requires such summary suspension. The Director~~
17 ~~shall provide written notice of such summary suspension to the Massage Practitioner by hand delivery~~
18 ~~or registered mail.~~

19 (b) The Director may not suspend or revoke a Massage Practitioner permit under this Article
20 29 until the Director has issued a Notice of Violation and provided the Massage Practitioner an
21 opportunity to be heard and respond as provided in Section 29.43 of this Article 29.

22 (c) Notwithstanding subsection (b) of this Section 29.18, the Director may suspend summarily
23 any Massage Practitioner permit issued under this Article 29 when, in the judgment of the Director, an
24 extreme public health hazard requires such summary suspension. The Director shall provide written
25 notice of such summary suspension to the permit holder by hand delivery, registered mail, or electronic

1 mail. No more than three days after written notice of such summary suspension is given, the Director
2 shall issue a Notice of Violation identifying the alleged acts or failures to act that constitute the basis
3 for the summary suspension, and provide the Massage Practitioner an opportunity to be heard and
4 respond as provided in Section 29.43 as to why the summary suspension should end. However, the time
5 for hearing and decision shall be accelerated as follows: Upon a timely request for a hearing, the
6 Director shall set any requested hearing within seven days, unless time is extended by mutual
7 agreement of the affected parties; and the Director, or a designated hearing officer who shall have the
8 same authority as the Director to hear and decide the case, and make any orders consistent with this
9 Article 29, shall issue a decision on the summary suspension within three days after hearing.

10 (d) If the Permittee appeals a decision by the Director or hearing officer upholding a summary
11 suspension to the Board of Appeals, the summary suspension shall remain in effect until a final decision
12 is issued by the Board of Appeals. Where a permit is revoked after a summary suspension, the
13 revocation shall be effective immediately and, if the Permittee appeals to the Board of Appeals, shall
14 remain in effect until a final decision is issued by the Board of Appeals.

15
16 **SEC. 29.25. MASSAGE BUSINESS PERMIT REQUIRED; EXEMPTIONS.**

17 (a) **Permit Required.** It shall be unlawful for any Owner of a Massage Establishment,
18 Sole Practitioner Massage Establishment, or Outcall Massage Service to operate that
19 Massage Business at any location in the City without first obtaining a permit for such Massage
20 Business from the Director. In the event that a business owner or operator disclaims that the
21 business is a Massage Business, the Director may hold a hearing to determine whether a
22 permit under this Section 29.25 is required.

23 (b) **Exemptions.** The following businesses may provide Massage services without
24 obtaining a Massage Business permit:
25

1 (1) Businesses providing Massage services performed solely by physicians,
2 surgeons, chiropractors, osteopaths, nurses, or any physical therapists, who are duly licensed
3 to practice their respective professions in the State of California and persons working directly
4 under the supervision of or at the direction of such licensed persons, working at the same
5 location as the licensed person, and administering massage services subject to review or
6 oversight by the licensed person.

7 (2) Businesses providing Massage services performed solely by barbers or
8 cosmetologists who are duly licensed under the laws of the State of California, while engaging
9 in practices within the scope of their licenses, and limited to the massaging of the neck, face,
10 scalp, hands, or feet of the clients.

11 (3) Hospitals, nursing homes, mental health facilities, or any other health
12 facilities duly licensed by the State of California, providing Massage services performed solely
13 by their employees acting within the scope of their employment.

14 ~~(c) Previously Exempt Massage Businesses. A Massage Business previously exempt from the~~
15 ~~Massage Business permit requirement under prior Section 29.9 but not currently exempt under~~
16 ~~subsection (b) of this Section 29.25 may continue to operate without a permit until its application for a~~
17 ~~permit is submitted and decided; provided that the Owner submits a completed application within 90~~
18 ~~days of the effective date of the ordinance deleting former Section 29.9,* and further provided that the~~
19 ~~Massage Business complies with all provisions of this Article 29 and any rules and regulations that~~
20 ~~apply to Massage Businesses during the interim period in which it operates without a permit. The~~
21 ~~Director may conduct a public hearing on the application, as provided in Section 29.29(b). The~~
22 ~~Director may deny the application for a Massage Business permit on any ground enumerated in~~
23 ~~Sections 29.29 and 29.33, grant the permit, or grant the permit with conditions.~~

1 **SEC. 29.26. APPLICATION FOR MASSAGE ESTABLISHMENT, SOLE**

7 (2) Provide a complete set of fingerprints in the manner required by the
8 Director from any person with an ownership interest in the Massage Business for the purpose
9 of ~~a~~ undergoing a criminal background check; *and*

10 (3) Pay a non-refundable application fee, as set forth in Section 29.41; and
11 (4) Permit inspection of any Massage facilities proposed to be operated under
12 the permit by all relevant City departments; *including but not limited to the Department of Building*
13 *Inspection, the Planning Department, and the Fire Department.*

14 (b) **Applicant Information.** The application form shall require the applicant to provide,
15 under penalty of perjury, the following information:

16 (1) The name(s), address(es), and any other identifying information regarding
17 the Owner(s) as requested by the Director;

18 (2) A description of all services to be rendered by the Massage Business;

19 (3) The address of any facilities proposed to be operated under a Massage
20 Establishment or Sole Practitioner Massage Establishment permit, and a copy of the rental
21 agreement or lease showing the names of the landlord and all of the tenants or lessees who
22 are parties to the rental agreement; or, if the Owner owns the premises, a copy of the deed
23 and a disclosure of any other person or entity with a shared ownership interest in the
24 premises;

1 (4) The number of individuals to be employed by the Massage Business, and,
2 except in the case of a Sole Practitioner Massage Establishment, the names and permit or
3 certificate numbers of any Massage Practitioners or CAMTC Certified Practitioners who shall
4 operate under that permit;

5 (5) All permits, certificates, or licenses related to the practice of Massage or the
6 operation of a Massage Establishment or Massage service, currently or formerly held by an
7 Owner, issued in San Francisco or elsewhere, including any discipline imposed by the issuing
8 authority and a statement whether the permit holder is currently the subject of a disciplinary
9 process; *and*

10 (6) All felony or misdemeanor convictions for each person with an ownership
11 interest in the Massage Business; *and*

12 (7) A floor plan of the proposed Massage Establishment, indicating the location of all
13 Massage treatment rooms, Massage tables, Massage chairs, and employee areas;

14 (8) A certificate of insurance against liability for workers compensation or proof of
15 self-insurance in accordance with the provisions of the California Labor Code; and

16 ~~(79)~~ Any additional information as required by the Director.

17 (c) **Organizational Owners.** If the Owner of the Massage Establishment or Outcall
18 Massage Service is or includes a corporation, the name of the corporation shall be set forth
19 exactly as shown in its articles of incorporation together with the names and residence
20 addresses of each of the officers, directors, and each stockholder holding more than 10%
21 *percent* of the stock of the corporation. If the Owner is or includes a partnership, the
22 application shall set forth the name and the residence address of each of the partners,
23 including limited partners. If one or more of the partners is a corporation, the provisions of this
24 ~~§~~ subsection 29.26(c) pertaining to corporate applicants applies. The applicant shall provide
25 the information required in subsections (a)(2), (b)(1), (b)(5), and (b)(6) of this Section 29.26 for

1 each officer, director, and stockholder holding more than 1-0% ~~percent~~ of the stock of the
2 corporation, or for each partner, including limited partners.

3 (d) **Proof of Massage Practitioner Permit or CAMTC Certification for Sole**
4 **Practitioners.** In addition to the information required under subsection (b) of this Section
5 29.26, an applicant for a Sole Practitioner Massage Establishment permit shall provide proof
6 that he or she holds either a current, valid Massage Practitioner permit or a CAMTC certificate.
7 A Massage Practitioner may not hold both a Massage Practitioner permit and a CAMTC certificate.

8 (e) **Massage Establishment Compliance with Planning Code Notice**
9 **Requirement.** An Applicant for a Massage Establishment permit shall also submit proof of
10 compliance with any applicable Planning Code requirements regarding notice and posting of
11 the proposed Massage Establishment.

12 (f) Deadline for submission of supporting documentation. After reviewing a Massage
13 Business permit application, the Director shall notify the applicant in writing that the application is
14 complete and accepted for further review, or incomplete. If the Director deems the application to be
15 incomplete, the applicant shall supply the information or documentation that is required for the
16 application to be deemed complete. The applicant shall have 60 days from the date that the Director
17 provides notification that the application is incomplete to provide all required information and/or
18 documentation. If the applicant does not provide such information within 60 days, the application will
19 be deemed abandoned and will not receive further consideration.

21 **SEC. 29.27. REQUIREMENTS FOR MASSAGE FACILITIES.**

22 All proposed massage facilities must comply with the following requirements, and with
23 any rules and regulations adopted by the Director pursuant to Section 29.2:

24 (a) **Toilet Rooms and Other Rooms.** Toilet rooms shall be provided for clients in
25 convenient locations.

1 (1) Construction of rooms used for toilets, laundry, and mop sinks, as well as
2 rooms used for tubs, wet tables, steam baths, saunas, and showers stalls, shall be made of
3 waterproof, ~~with hard~~ nonabsorbent materials that are easily cleaned and shall be installed in
4 accordance with the San Francisco Building Code.

5 (2) Plumbing fixtures in toilet rooms as well as rooms used for tubs, steam
6 baths, and showers shall be installed in accordance with the San Francisco Plumbing Code.

7 (3) Urinals may be substituted for toilets after one toilet has been provided.

8 (4) Doors to toilet rooms shall open inward ~~and be self-closing~~.

9 (b) **Handwashing Facilities.** Handwashing facilities shall be provided within or
10 adjacent to the toilet rooms and shall be equipped with an adequate supply of hot and cold
11 running water under pressure.

12 (1) Handwashing facilities must provide liquid hand soap in a pump or a wall-
13 mounted dispenser and sanitary wall mounted disposable paper towels.

14 (2) Handwashing facilities shall be readily accessible to massage practitioners.

15 (c) **Light and Ventilation.** All portions of the Establishment shall be provided with
16 adequate light by means of windows, skylights, or with an approved artificial light. Adequate
17 ventilation shall be provided by means of windows or a mechanical operating ventilating
18 system.

19 (1) Toilet, dressing, and massage rooms shall be provided with at least 108 lux
20 (10 foot candles) of light.

21 (2) All electrical equipment shall be installed in accordance with the
22 requirements of the San Francisco Electrical Code.

23
24 **SEC. 29.29. ISSUANCE OF MASSAGE ESTABLISHMENT, SOLE PRACTITIONER**
25 **MASSAGE ESTABLISHMENT, OR OUTCALL MASSAGE SERVICE PERMIT.**

1 (a) Within ~~60~~90 business days following receipt of a completed application for a
2 Massage Business permit, or, for applications subject to referral under Section 29.28, within
3 30 days of receiving all written findings, whichever is later, the Director shall either issue the
4 permit or mail a written statement of his or her reasons for denial thereof to the applicant. If
5 the Director takes neither action, the permit shall be deemed issued.

6 ~~(b) Hearing on Application. The Director may, in his or her discretion, hold a hearing on any~~
7 ~~pending application for a Massage Establishment, Sole Practitioner Massage Establishment, or Outcall~~
8 ~~Massage Service permit. The Director shall give the applicant at least 10 days' written notice of the~~
9 ~~time and place of the hearing.~~

10 (e**b**) No Massage Establishment, Sole Practitioner Massage Establishment, or Outcall
11 Massage Service permit shall be issued if the Director finds:

12 (1) The applicant has provided materially false information, documents, or
13 testimony in support of the application or in any other matter before the Director; or

14 (2) The facilities as proposed by the applicant would not comply with all
15 applicable laws including, but not limited to, the facilities requirements set forth in Section
16 29.27, the City Building, Planning, Housing, and Fire Codes, or any rule or regulation related
17 to Massage facilities adopted by the Director pursuant to this Article 29; or

18 (3) Within one year prior to the application, the applicant has had any license or
19 permit of any kind suspended or revoked by the Director; or

20 (4) ~~Within five years immediately p~~Prior to the date of application, the applicant
21 has had any license, certificate, or permit related to the practice of Massage or operation of a
22 Massage Establishment or Massage service revoked; or

23 (5) The applicant has been Convicted of any of the following offenses:

(8) The Director finds that the premises or the Massage Business will be or is being managed, conducted, or maintained in such a manner as to endanger the health and safety of the employees or clients, or to coerce any employee to engage in illegal conduct; or

(9) The applicant has not fully complied with the provisions of this Article 29; or

(190) The applicant has not demonstrated eligibility for a permit under this Article 29.

~~(d)~~ **Discretionary Exception for Criminal Convictions.** The Director may issue a permit otherwise authorized under this Section to any Owner Convicted of one of the offenses listed in subsection ~~(eb)~~(5) of this Section 29.29 if the Director finds that the offense was not violent, the conviction occurred at least five years prior to the date of application, and the applicant has not been convicted subsequently of any of the listed offenses.

1 ~~(e) Sole Practitioner Massage Establishments. Notwithstanding the provisions of Section 29.5,~~
2 ~~the Director may issue a Sole Practitioner Massage Establishment permit authorizing more than four~~
3 ~~Massage Practitioners or CAMTC Certified Practitioners to operate out of the same location if the~~
4 ~~Director finds good cause exists and the operation of the Sole Practitioner Massage Establishment will~~
5 ~~not have a negative impact on the neighborhood.~~

6 **(fd) Right to Director's Hearing.** If an application for a Massage Establishment, Sole
7 Practitioner Massage Establishment, or an Outcall Massage Service permit is denied, *and*
8 ~~provided that the Director did not hold a hearing on the application as provided in subsection (b) of~~
9 ~~this Section,~~ the applicant may appeal the denial within 3015 days of receipt of the date listed on
10 the notice of denial by notifying the Director in writing and explaining the ground or grounds
11 for the appeal. Within 3060 days of receipt of the notice of appeal, the Director shall conduct a
12 hearing to consider the appeal. At least 10 days prior to the hearing, the Director shall notify
13 the applicant of the time and place of the hearing. The Director shall oversee the hearing,
14 provide the applicant an opportunity to speak at the hearing, and issue a ruling within 3060
15 days of the conclusion of the hearing. If the Director fails to rule within this time period, the

19 **SEC. 29.31. OPERATING REQUIREMENTS.**

20 Massage Establishments, Sole Practitioner Massage Establishments, and Outcall
21 Massage Services must comply with the following operating requirements to the extent
22 applicable:

23 **(a) Cleanliness and Hygiene.** Massage facilities, including all appliances and
24 apparatuses, shall be kept clean and operated in a sanitary condition.

1 (1) Adequate and suitable space shall be provided for storage of clean linens,
2 including, but not limited to, sheets, towels, and apparel.

3 (2) Clean sheets and towels shall be provided, laundered after each use, and
4 stored in a sanitary manner.

5 (3) No towels or sheets shall be laundered or dried on the premises in the
6 absence of suitable laundry facilities.

7 (4) Smooth, cleanable, and appropriately labeled receptacles for the storage of
8 soiled linens and towels shall be provided.

9 (5) Soiled refuse shall be appropriately bagged and disposed of.

10 (6) Wet and dry heat rooms, shower compartments, and toilet rooms shall be
11 thoroughly cleaned each business day.

12 (7) Bathtubs shall be thoroughly cleaned and sanitized after each use.

13 (8) The facility shall be free of vermin, including but not limited to cockroaches, mice,
14 rats, and other pests that carry disease.

15 (b) **Changing Area.** A room, enclosure, or designated area shall be provided where
16 clients can change and store their clothes.

17 (c) **Employee Area.** A room, enclosure, or designated area that is separate from the
18 toilet, massage room(s), steam room, or other common areas shared by the clients shall be
19 made available to employees at all times. The employee area(s) shall be furnished with individual
20 lockers and adequate storage space for employees' personal belongings. Members of the public may
21 not have access to the employee area.

22 (d) **Employment of Minors Prohibited.** It shall be unlawful to employ any individual
23 who is not at least 18 years of age.

24 (e) **Register of Practitioners.** Every Massage Establishment or Outcall Massage
25 Service that hires or contracts with individuals to provide Massage services shall ensure at all

1 times that each such individual holds a valid and current Massage Practitioner permit or
2 CAMTC certificate. The Massage Establishment or Outcall Massage Service shall maintain a
3 register of practitioners that includes each practitioner's permit or CAMTC certificate number,
4 which shall be available for inspection by the Department at all times.

5 (f) **Practitioner Conduct.** Massage Establishments shall be responsible for the
6 conduct of all individuals providing Massage for Compensation on their business premises
7 and shall ensure that such individuals do not wear improper attire or engage in lewd conduct
8 as set forth in Section 29.17.

9 (g) ~~Doors to Remain Unlocked~~**Locks.** ~~Massage Establishment interior~~Doors that permit entry
10 into any treatment room may not be equipped with locks or any device designed to prevent, impede, or
11 delay entry into a room. Massage Establishment and exterior doors may be equipped with locks, but
12 shall remain unlocked while the Massage Establishment is open. Exterior doors may remain
13 locked while the Massage Establishment is open only if the Massage Establishment is owned by one
14 individual with no more than one employee or independent contractor. ~~there is no more than one~~
15 employee or independent contractor on the premises of the Establishment, exclusive of the
16 Establishment owner.

17 (h) **No Alcohol or Illegal Drugs Permitted on Premises.** No alcoholic beverages or
18 drugs may be sold, served, used, or possessed on business premises during business hours.
19 "Alcoholic beverage" includes a mixture of one or more alcoholic beverages ingested
20 separately or as a mixture as defined in Section 23004 of the California Business and
21 Professions Code. "Drug" shall include all narcotics, drugs, or controlled substances as
22 defined in Chapter 2 (commencing with Section 11053) of Division 10 of the California Health
23 and Safety Code.

24 (i) **Human Trafficking Information Notices.** Massage Establishments must comply
25 with the requirements of California Civil Code Section 52.6. The required notices of human

1 trafficking information and telephone hotline numbers shall be posted in English, Spanish,
2 ChineseCantonese, Vietnamese, and other appropriate languages as determined by the
3 Department.

4 (j) **Residential Use.** Massage facility premises shall not be used as a sleeping room
5 or for any other residential purpose. A Massage Establishment shall be presumed to be used for
6 residential purposes if any of the following items are maintained on the premises:

7 (1) Beds or mattresses, other than professional Massage tables;

8 (2) Bedding, such as pillows, blankets, and sheets, other than those used for
9 professional Massage tables;

10 (3) Sleepwear, including but not limited to, pajamas, nightgowns, and lingerie;

11 (4) Groceries that require cooking, such as raw meats, poultry, fish, and grains; or

12 (5) Clothing that exceeds one change of clothing for each employee or independent
13 contractor who is present on the premises.

14 (k) **Establishment Permit to be Displayed.** Every permit to operate a Massage
15 Establishment or Sole Practitioner Massage Establishment shall be displayed in a
16 conspicuous place within the Establishment such that the permit may be readily seen by
17 individuals entering the premises.

18 (l) **Outcall Massage Service Permit Subject to Inspection.** Every permit to operate
19 an Outcall Massage Service must be made available for inspection by the Department at all
20 times while providing Massage services.

21 (m) **Hours of Operation.** No Massage Business shall operate or provide Massage
22 services, and no customer or person not employed or contracted by the Massage Business may be on
23 the premises of a Massage Establishment, during the hours between 10:00 p.m. and 7:00 a.m.

24 (n) Advertising. No Massage Business shall publish or distribute, or cause to be published or
25 distributed, including on the internet, any advertising for services that would violate this Article 29.

1 (o) Operation of Massage School Prohibited. No Massage Business shall operate a Massage
2 school or otherwise provide instruction in Massage on the premises of a Massage Establishment.

3
4 **SEC. 29.32. INSPECTION.**

5 Any member of the Department may inspect any Massage Establishment or Sole
6 Practitioner Massage Establishment to determine whether the Establishment is operating in
7 compliance with the provisions of State law or this Article 29, or for the purpose of providing
8 educational materials to employees of the Establishment in culturally and linguistically
9 appropriate languages regarding the City and County of San Francisco Sanctuary City policy,
10 employee rights, and information on a variety of resources, including linkage to health care
11 services, victim services, and emergency numbers and hotlines to call for information and
12 assistance. ~~The Director shall adopt regulations governing the use of double doors or other structural~~
13 ~~devices that interfere with reasonable inspections and do not have legitimate safety or security~~
14 ~~purposes.~~ Nothing in this Section shall be construed to limit or restrict the lawful authority of a
15 police officer or other City employee to enter premises licensed under this Article 29.

17 **SEC. 29.33. SUSPENSION OR REVOCATION OF MASSAGE ESTABLISHMENT,**
18 **SOLE PRACTITIONER MASSAGE ESTABLISHMENT, OR OUTCALL MASSAGE**
19 **SERVICE PERMIT.**

20 (a) **Grounds for Suspension or Revocation.** The Director may revoke or suspend
21 any Massage Establishment, Sole Practitioner Massage Establishment, or Outcall Massage
22 Service permit, after a hearing, if the Director finds:

23 (1) Facts sufficient to support the denial of such permit on any ground set forth
24 in Section 29.29; or

1 (2) The permittee or the permittee's agent, employee, or independent contractor has

3 with City staff in the performance of an inspection such as by threatening them, touching them, or
4 intentionally delaying their entry to the premises of the Massage Business; or

6 engaged in any conduct in connection with the operation of the business that violates the
7 operating requirements set forth in Section 29.31 this Article 29, any rules or regulations related
8 to Massage Business operations, or any State or local laws relating to the practice of Massage or
9 the operation of a Massage Business; or

10 ~~(4) Any employee or independent contractor of the permittee has engaged in conduct~~
11 ~~that violates any state or local laws at permittee's place of business, and the permittee had or, in the~~
12 ~~exercise of due diligence, should have had knowledge of the prohibited conduct; or~~

13 (5) The Director determines that such Massage Business is being managed,
14 conducted, or maintained without regard for public health or the health of clients or
15 employees, or without due regard for proper sanitation and hygiene; or

16 (6) The Director finds good cause to suspend or revoke the permit in
17 accordance with Sections 24 or 26 of Article 1 of the Business and Tax Regulations Code
18 Sections 24 and 26.

19 ~~(b) Hearing. A permit holder cited for a violation of any provision of Article 29 or the rules~~
20 ~~and regulations promulgated by the Director under Section 29.2 shall be scheduled to appear at a~~
21 ~~hearing held by the Director. The Director shall provide the permittee at least 10 days' written notice~~
22 ~~of the time, place, and grounds for the hearing. If requested by permittee, the Director shall make~~
23 ~~available all documentary evidence against permittee within five days of the request. If the Director~~
24 ~~does not provide the requested documentary evidence within five days, the permit holder may request,~~
25 ~~and the Director shall grant, a continuance of the hearing date. At the hearing, the permittee shall be~~

1 ~~provided an opportunity to refute all evidence against him or her. The Director shall oversee the~~

5 ~~(e) Summary Suspension. The Director may suspend summarily any Massage Establishment,~~

7 ~~pending a noticed revocation or suspension hearing when, in the opinion of the Director, the public~~
8 ~~health or safety requires such summary suspension. The Director shall provide written notice of such~~
9 ~~summary suspension to the permit holder by hand delivery or registered mail.~~

10 ~~(b) The Director may not suspend or revoke a Massage Business permit under this Article 29~~
11 ~~until the Director has issued a Notice of Violation and provided the Massage Business and the owner of~~
12 ~~the property upon which the Massage Business is located an opportunity to be heard and respond as~~
13 ~~provided in Section 29.43 of this Article 29.~~

14 ~~(c) Notwithstanding subsection (b) of this section 29.33, the Director may suspend summarily~~
15 ~~any Massage Business permit issued under this Article 29 when, in the judgment of the Director, an~~
16 ~~extreme public health hazard requires such summary suspension. The Director shall provide written~~
17 ~~notice of such summary suspension to the permit holder by hand delivery, registered mail, or electronic~~
18 ~~mail. No more than three days after written notice of such summary suspension is given, the Director~~
19 ~~shall issue a Notice of Violation identifying the alleged acts or failures to act that constitute the basis~~
20 ~~for the summary suspension, and provide the Massage Business an opportunity to be heard and~~
21 ~~respond as provided in Section 29.43 as to why the summary suspension should end. However, the time~~
22 ~~for hearing and decision shall be accelerated as follows: Upon a timely request for a hearing, the~~
23 ~~Director shall set any requested hearing within seven days, unless time is extended by mutual~~
24 ~~agreement of the affected parties; and the Director, or a designated hearing officer who shall have the~~

1 same authority as the Director to hear and decide the case, and make any orders consistent with this
2 Article 29, shall issue a decision on the summary suspension within three days after hearing.

3 (d) If the Permittee appeals a decision by the Director or hearing officer upholding a summary
4 suspension to the Board of Appeals, the summary suspension shall remain in effect until a final decision

6 revocation shall be effective immediately and, if the Permittee appeals to the Board of Appeals, shall

10 **ESTABLISHMENT, AND OUTCALL MASSAGE SERVICE FEES.; REINSPECTION FEES.**

11 (a) **Massage Establishments.** The application fee for a Massage Establishment
12 permit shall be \$681. The annual license fee for a Massage Establishment shall be \$1,214.
13 The fee shall be due annually on March 31 of each year, pursuant to Section 76.1, Article 2 of
14 the Business and Tax Regulations Code.

15 (b) **Sole Practitioner Massage Establishments.** The application fee for a Sole
16 Practitioner Massage Establishment permit shall be \$497. The annual license fee for a Sole
17 Practitioner Massage Establishment shall be \$599. The fee shall be due annually on March 31
18 of each year, pursuant to Section 76.1, Article 2 of the Business and Tax Regulations Code.

19 (c) **Outcall Massage Services.** The application fee for an Outcall Massage Service
20 permit shall be \$351. The annual license fee for an Outcall Massage Service shall be \$306.
21 The fee shall be due annually on March 31 of each year, pursuant to Section 76.1, Article 2 of
22 the Business and Tax Regulations Code.

23 (d) **Exception.** A Massage Practitioner or CAMTC Certified Practitioner holding a
24 Sole Practitioner Massage Establishment permit shall not be required to pay any additional
25 application or annual license fee for an Outcall Massage Service permit.

1 (e) Reinspection fees. If an inspection discloses a violation of any provision of this Code or of
2 any State law for which the Department is responsible for enforcement, the Department shall determine
3 a period of time that is reasonable to correct the violation and shall thereafter reinspect the property to
4 verify such correction. The term "reinspection" shall refer to any inspection by the Department to verify
5 whether an owner has corrected a violation. The Massage Business shall pay a fee in the amount of
6 \$191 for the first hour or any fraction thereof for each reinspection by an Inspector, to compensate the
7 Department for its costs in performing the reinspection. Reinspections that require more than one hour
8 to complete shall be subject to an additional fee at the rate of \$96 for each half-hour or part thereof
9 beyond the first 60 minutes. If more than one reinspection is necessary to secure correction of a
10 violation, the Massage Business shall pay a fee in the amount set forth herein for each reinspection. In
11 the event that the Massage Business fails to pay any reinspection fee due under this Section within 30
12 days of the due date, the Massage Business must pay a late payment penalty of \$40 and the City may
13 collect the reinspection fee through the placement of a lien in the amount of the fee and any late
14 payment penalty owed or delinquent, plus interest of 1.5% per month, against the real property
15 pursuant to the procedures set forth in Chapter 10, Article XX of the Administrative Code (beginning
16 with Section 10.230).

17
18 **SEC. 29.42. ADJUSTMENT OF FEES.**

19 Beginning with fiscal year 2008-2009, fees set forth in this Article 29 may be adjusted
20 each year without further action by the Board of Supervisors. Not later than April 1, the
21 Director shall report to the Controller the revenues generated by the fees for the prior fiscal
22 year and the prior fiscal year's costs of operation, as well as any other information that the
23 Controller determines appropriate to the performance of the duties set forth in this Section
24 29.42. Not later than May 15, the Controller shall determine whether the current fees have
25 produced or are projected to produce revenues sufficient to support the costs of providing the

2 any other Person deemed responsible for causing the violation(s) has the right to request a hearing
3 before the Director within 15 days after the Notice of Violation is issued, which request must be made
4 in writing.

5 (c) If no request for a hearing is filed with the Director within the appropriate period, the right
6 to request a hearing shall be deemed waived, and the Director's determination shall become final and
7 effective 15 days after the Notice of Violation was mailed. The Director shall issue an order imposing
8 the enforcement action, and shall send the order to the Persons served with the Notice of Violation by
9 hand delivery, registered mail, or electronic mail. In subsequent civil proceedings, such violations
10 shall be deemed not to have been corrected. Where no hearing is timely requested, an order suspending
11 or revoking a permit is final. The failure of the Person on whom the Notice of Violation is served to
12 request a hearing shall constitute a failure to exhaust administrative remedies and shall preclude the
13 Person from obtaining judicial review of the validity of the enforcement action.

14 (d) Upon a timely request for a hearing, the Director shall, within 15 days of the request,
15 notify the requester of the date, time, and place of the hearing. Such notification may be made by hand
16 delivery, registered mail, or electronic mail. The Director shall make available to the requester the
17 photographs and other recorded evidence obtained in support of the Notice of Violation as well as a
18 copy of the report prepared by the Director's designee, if any, to support the Notice of Violation. Such

6 parties. In no court case or special proceeding shall an award of attorneys' fees to a prevailing party
7 exceed the amount of reasonable attorneys' fees incurred by the City.

11 Section 2. The Health Code is hereby amended by revising Section 581, to read as

4 of Supervisors overrides the Mayor's veto of the ordinance.

6 Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors
7 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,
8 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal
9 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment
10 additions, and Board amendment deletions in accordance with the "Note" that appears under
11 the official title of the ordinance.

REVISED LEGISLATIVE DIGEST
(Amended in Board, 10/30/2018)

[Health Code - Massage Practitioner and Business Permits]

Ordinance amending the Health Code to comprehensively revise the regulation of massage practitioners, massage establishments, massage outcall services, and sole practitioner massage establishments by, among other things: 1) authorizing the Director of Health (“Director”) to access local, state, and federal criminal history information of permit applicants and permit holders; 2) eliminating temporary massage practitioner permits; 3) clarifying the administrative process by which permit applicants and permit holders may appeal a decision to deny, suspend, or revoke a permit; 4) adding or revising massage establishment operating standards relating to vermin, employee areas, locked doors, residential use, and advertising; 5) prohibiting a massage business from operating a massage school on the same premises as a massage establishment; 6) establishing a massage establishment reinspection fee of \$191 per hour; 7) updating administrative and permit penalties; 8) authorizing the imposition of a lien on a property that has contributed to a violation of Article 29 of the Health Code (“Article 29”) to collect unpaid administrative penalties, enforcement costs, fines, interest, and attorneys’ fees; 9) authorizing the City Attorney to institute civil proceedings for injunctive and monetary relief for violations of Article 29; 10) declaring violations of select provisions of Article 29 to be public nuisances; and 11) discontinuing the acceptance of applications for massage practitioner permits effective January 1, 2019.

Existing Law

Article 29 of the Health Code provides a comprehensive permitting and regulatory framework for massage practitioners and massage businesses over which the San Francisco Department of Public Health (“DPH”) has jurisdiction.

A massage practitioner requires a permit issued by DPH in order to provide massage services unless the practitioner holds a certificate to practice issued by the California Massage Therapy Council (“CAMTC”). A massage business must hold a permit from DPH in order to operate.

Applicants for massage practitioner permits must pass criminal background checks and demonstrate compliance with instructional requirements. Applicants for massage business permits must also pass criminal background checks and supply substantial information about their proposed business. Massage businesses are subject to numerous operating requirements designed to protect the health and safety of massage business employees and customers.

Violations of Article 29 may subject massage practitioners and massage businesses to administrative fines and suspension or revocation of their permit, following notice of the violation and an opportunity to be heard at an administrative hearing.

Amendments to Current Law

The proposed ordinance would change the current regulatory scheme by:

- Authorizing the Director of DPH to access summary criminal history information to facilitate the approval, denial, suspension, and/or revocation of massage permits;
- Imposing a deadline of December 31, 2018 for the submission of an application for a massage practitioner permit;
- Clarifying the process by which a permit applicant or permit holder may appeal administrative and permit penalties;
- Requiring applicants for massage business permits to submit to DPH a floor plan of the proposed business and proof of workers compensation coverage;
- Updating and/or establishing massage business operating standards to: require that the facility is free of vermin; establish a presumption that a massage business is being used as a residence, in violation of Article 29, if items such as sleepwear, groceries, and bedding are present; prohibit a massage business from advertising services that would violate Article 29; and prohibit a massage business from operating a massage school on the same premises;
- Increasing administrative fines and permit penalties for select violations of Article 29;
- Requiring that notices of violation relating to massage businesses be sent to the owner of the real property in which the business is located, and providing the real property owner with an opportunity to participate in the administrative appeals process;
- Authorizing the City Attorney to institute civil proceedings for injunctive and monetary relief for violations of Article 29;
- Revising the list of languages into which human trafficking notices must be translated and posted by eliminating Vietnamese and adding Chinese;
- Providing that violations of select provisions of Article 29 constitute prohibited public health nuisances, subject to fines and penalties set forth in Article 11 of the Health Code.

Background Information

This legislative digest reflects revisions introduced in the Land Use and Transportation Committee on October 15, 2018, and at a meeting of the full Board of Supervisors on October 30, 2018.

One of the purposes of Article 29 is to ensure that massage establishments do not become outlets of the sex trade and engage in human trafficking and other human rights violations.

Enforcement of Article 29 by DPH and the City Attorney's Office has helped to increase compliance with standards that promote the health and safety of massage establishments' employees and customers, but violations continue to occur, including violations of the provisions of Article 29 that prohibit lewd acts. The proposed ordinance includes amendments that are intended to eliminate enforcement loopholes, and discourage conduct that puts worker and client safety at risk.

In addition, since 2015 when Article 29 was last amended, CAMTC has become the primary licensing agency for massage practitioners. In 2017, DPH processed only four applications for massage practitioner permits. To avoid a duplication of efforts, the proposed ordinance would establish December 31, 2018 as the last date that DPH will accept massage practitioner permit applications. After that date, individuals wishing to work as massage practitioners will be required to seek certification from CAMTC. Those practitioners who are currently permitted by DPH will retain their DPH permits, and be subject to DPH regulation.

If this legislation passes, Health Code, Section 29.41, will be amended by adding a new reinspection fee. If an inspection discloses a violation of any provision of the Code or any State law for which the Department of Public Health (Department) is responsible for enforcement, the Department shall determine a period of time that is reasonable to correct the violation and shall thereafter reinspect the property to verify such correction. Reinspection refers to any inspection by the Department to verify whether an owner has corrected a violation. The massage business shall pay a fee in the amount of \$191 the first hour, or any fraction thereof, for each reinspection by an inspector to compensate the Department for costs in performing the reinspection. Reinspections that require more than one hour to complete shall be subject to an additional fee at the rate of \$96 for each half-hour, or part thereof, beyond the first 60 minutes. If more than one reinspection is necessary to secure correction of a violation, the Massage Business shall pay a fee of \$96 for each half-hour, or part thereof, beyond the first 60 minutes.

In accordance with Administrative Code, Section 67.7-1, persons who are unable to attend the hearing on this matter may submit written comments to the City prior to the time the hearing begins. These comments will be made as part of the official public record in this matter, and shall be brought to the attention of the members of the Committee. 
